Also during the fiscal year ended September 30, 2013, the Foundation made temporarily restricted net asset transfers to Newport Hospital amounting to \$600,169 to be spent by Newport Hospital in support of certain building and equipment additions or specified clinical programs. The use of funds is monitored by Foundation management to ensure that the funds are utilized for intended purposes.
