THE FOOD TRUST WORKS TO INCREASE ACCESS TO HEALTHY FOOD IN UNDERSERVED AREAS, ALONG WITH PROVIDING NUTRITION EDUCATION TO CHILDREN AND FAMILIES IN THE PAST YEAR, THE FOOD TRUST’S TEAM OF EDUCATORS CONDUCTED THE SCHOOL NUTRITION EDUCATION PROGRAM IN MORE THAN 100 ELEMENTARY, MIDDLE, AND HIGH SCHOOLS IN LOW-INCOME NEIGHBORHOODS OF PHILADELPHIA, NORRISTOWN, LANSDOWNE, AND READING, PA, AS WELL AS CAMDEN, NJ THE FOOD TRUST STAFF WORKED WITH APPROXIMATELY 65,000 CHILDREN AND THEIR FAMILIES, PROVIDING CLASSROOM LESSONS, PARENT WORKSHOPS, SCHOOL-WIDE ACTIVITIES SUCH AS TASTE TESTS AND NUTRITION-RELATED ASSEMBLIES, AND SPECIAL ACTIVITIES SUCH AS COOKING IN THE CLASSROOM AND FARM FIELD TRIPS PARTICIPATING TEACHERS ALSO RECEIVED NUTRITION EDUCATION MATERIALS FOR THEMSELVES AND THEIR STUDENTS, ALONG WITH LESSON PLANS TO HELP THEM INCORPORATE NUTRITION INTO THEIR CURRICULUM THE FOOD TRUST ALSO PROVIDES NUTRITION EDUCATION TO ADULTS IN LOW-INCOME COMMUNITIES OF PHILADELPHIA, NORRISTOWN, AND CHESTER, PA HELD IN CHURCHES, LIBRARIES, AND OTHER COMMUNITY SITES, THE SIX WEEK EDUCATION SESSIONS INTRODUCED PARTICIPANTS TO NEW FRUITS AND VEGETABLES, TAUGHT THEM HOW TO PREPARE HEALTHY MEALS, AND PROVIDED EDUCATIONAL TOURS OF NEARBY SUPERMARKETS, FARMERS’ MARKETS, AND HEALTHY CORNER STORES TO TEACH THEM HOW TO PURCHASE NUTRITIOUS FOOD ON A BUDGET
