We directly train teachers in economics, personal financial literacy, and entrepreneurship. We utilize programs and competitions to involve students in learning these topics: Stock Market Game, Personal Finance Challenge, Economics Challenge, Color the Concepts, Whit King Essay Contest.

The Stock Market Game: Two 10 week on-line trading games enjoyed by more than 11,000 students in 2011-12. Teams invest a virtual \$100,000 and compete! The program encourages kids to take an interest in their financial future. SMG is sponsored by Sterne Agee. SMG can be used as STEM curriculum piece. Math behind the Market, one of our curriculum pieces and workshops, help math teachers teach interest rates etc all the way to standard deviations, while allowing the students to 'play' a game. Boeing sponsored a series of workshops based on the Math behind the Market curriculum in North Alabama. Over 10,000 students participated in the 2011-12 school year.

4b (Code:) (Expenses \$ 29,363 including grants of \$ 24,360) (Revenue \$ 0)
The Personal Finance Challenge: Gives students grades 9-12 a chance to demonstrate their knowledge of personal finance in a fun and challenging way. We train the teachers to teach personal finance to their students. PFC is sponsored by Wells Fargo Bank. A competition always encourages the students to learn more. It also measures the effectiveness of the training. We are making progress in this area, but Alabama students are in desperate need of personal financial literacy training. ACEE provided workshops with 334 teachers attending. Almost 1100 students participated in the challenge.

4c (Code:) (Expenses \$ 9,519 including grants of \$ 15,000) (Revenue \$ 0)
Workshops in Personal Finance & Economics: Direct training of teachers using the Virtual Economics 4.0 curriculum which provides lesson plans for k-12 teachers to use while teaching social studies, math and literature. Grant provided by the Council for Economic Education, the Daniel Foundation, and Regions Bank. Including the Personal Finance teachers trained, ACEE 445 teachers impacting 41,819 students. 48% of the teachers trained were from schools with over 50% free and reduced lunch.

The Alabama Council does many other projects throughout the year, from The Economics Challenge to the Economics Extravaganza (an all day workshop for teachers). We train teachers around the state offering free materials with the training so they can better incorporate financial responsibility and economics into their classrooms. This is where our other program expenses are spent.

Most of the salaries are expended through direct work on our projects and not through administration.

In regards to Part VIII, Line 2g, our program service revenue consists of activities regularly carried out as one our substantial exempt purposes.

ACEE trained 445 teachers in 2012-13, which is a 32% increase over 2011-12. 48% of the teachers are from schools with 50% or more free/reduced lunch rate. 41,819 students were impacted. Teachers showed an average of 25% increase in learning based on pre/post tests. 62% of Alabama school systems participated in ACEE programs and/or teacher workshops.

Our largest program expenses are: Curriculum \$ 429,837, Prizes \$7,708 (for students involved in our contests), Stipends 47,350 (for teachers and/or students to travel to our workshops/state championships), Substitute Pay \$3,248 (some teachers cannot attend workshops without sub pay) and travel \$10,483 (mileage primarily for our trainers to go throughout the state).

In terms Part VI, Section B, Line 11a, we provide a copy of the 990 to our board after it is filed. The Board Treasurer, Randy DeRieux goes over the form before it is filed. Anyone can request any of our governing documents, and ACEE will promptly send them.

ACEE is pleased to cooperate with the University of Alabama Birmingham, Troy University at Dothan, University of West Alabama and Auburn University at Montgomery.
