During Fiscal Year 2013, the Foundation directly contributed \$5,432 to Brevard Urgent Care/Frances Warde Family Health (FWFH)  
for purchase of a new x-ray machine/equipment that will replace failing equipment in the center. The equipment is needed to assess  
patient injuries for fracture care. Brevard Urgent Care and FWFH, both located in Brevard, NC, saw a combined total of 7,040  
patients in FY 13. Approximately 25% or 1,760 patients will benefit from the new machine annually.  
\$23,174 was transferred to Sisters of Mercy Services for reimbursement of prior program expenses.

During Fiscal Year 2013, \$21,511 of direct expenses were used toward our medical mission program in Haiti. Staff and Board  
volunteers from Sisters of Mercy Urgent Care and Sisters of Mercy Services provided care to 1,904 Haitian patients  
during 2 mission trips and constructed a covered waiting area for patients at a local clinic.  
\$6,000 of the total amount was used to provide a generator to the Alpha and Omega Haitian Clinic; which we have supported  
since the Earthquake in 2010.
