The CS NYC project is funded by the New York City Adult & Children's Services (child welfare) agency and is part of a large system reform effort to implement linked evidence-based interventions that were developed and tested over the past two decades. This project provides training and support to implement three preventive evidence based practices (Keeping Foster and Kin Parents Supported and Trained, Parenting through Change and Youth Skills Coaching) simultaneously. Using these interventions, the CSNYC will change the routine practice of child welfare caseworkers such that they will implement evidence-based interventions with the children and families they serve. The New York City ACS is the first child welfare system nationwide to make this level of commitment to utilize EBPs (evidence based practice) as a matter of embedded practice and policy.

The CS NYC contracts are with the 5 participating agencies to actually implement KEEP, PTC and Youth Skills Coaching in their agencies.

4b (Code:) (Expenses \$ 192,280 including grants of \$ 0) (Revenue \$ 0)
The Child Study is a scientifically rigorous randomized controlled trial of the Friends of the Children (FOTC) program. It is intended to follow participants in the FOTC "intervention" group and a services as usual "control" group throughout the 12 years of the program and beyond, until the age of 25 years. The study was initially funded by the National Institutes of Health (NIH: specifically the National Institute of Mental Health and the National Institute on Child Health and Human Development) through Oregon Social Learning Center. The funding received through OSLC Developments has served as "bridge" funding as the study continues forward, and was received this year from the Robert Wood Johnson Foundation (RWJF), the Campbell Foundation and a subcontract with the University of Washington. Currently, short term funding from private foundations allows us to continue contact with families and schools and to collect and manage data as we apply for the future funding needed to complete the study. In prior years, "bridge" funding has also been received from the Edna McConnell Clark Foundation.

4c (Code:) (Expenses \$ 100,074 including grants of \$ 0) (Revenue \$ 0)
The ACF FIND project is a collaboration with Dr. Sarah Watamura at the University of Denver. Dr. Watamura is the Principal Investigator on a 5-year research grant from the Administration for Children and Families - A Microsocial Video-Coaching Intervention for Toxically Stressed EHS Families. This project focuses on some of the highest risk children enrolled in Early Head Start in the metro Denver area. These children are living in toxic stress conditions, putting the child at increasing risk for poor physical and psychological health. The project aims to test the Filming Interactions to Nurture Development (FIND) intervention with this population. FIND is a video coaching program for parents and other caregivers. FIND employs video of caregivers' natural interactions with their child to show them ways that they are supporting their child's healthy development and is a simple and practical approach that emphasizes the caregivers' strengths and capabilities. The five FIND elements are Sharing the Child's Focus of Attention, Supporting and Encouraging, Naming, Back & Forth Interaction and Child Led Endings and Beginnings.
