NORTH CANYON MEDICAL CENTER IS A 15 BED HOSPITAL THAT PROVIDES SERVICES THAT INCLUDE ACUTE CARE, SWING BED CARE FOR THOSE PATIENTS DISCHARGED FROM ACUTE CARE BUT REQUIRE ADDITIONAL SKILLED CARE, DIAGNOSTIC IMAGING, DIABETIC EDUCATION, EMERGENCY CARE, LABORATORY SERVICES, REHABILITATION SERVICES, RESPIRATORY THERAPY, SLEEP STUDIES, WOUND CARE, AND SURGICAL SERVICES. NCMC OFFERS STATE OF THE ART RADIOLOGY EQUIPMENT NOT NORMALLY FOUND IN A RURAL SETTING. NCMC EMPLOYS ONLY CERTIFIED RADIOLOGIC TECHNOLOGISTS TO PERFORM EXAMS, EACH HAVING SPECIALIZED TRAINING IN THE TYPE OF EXAM BEING GIVEN. ALSO, NORTH CANYON MEDICAL CENTER RECEIVED GRANT MONEY FROM THE SUSAN B KOMEN FOUNDATION THAT WAS USED TO FURTHER BREAST CANCER AWARENESS BY PROVIDING FREE BREAST IMAGING TO WOMEN WHO ARE UNINSURED OR UNDERINSURED

NORTH CANYON MEDICAL CENTER'S MEDICAL SURGICAL DEPARTMENT HANDLES ACUTE CARE AS WELL AS SWING BED CARE. SWING BED CARE IS FOR THOSE PATIENTS DISCHARGED FROM ACUTE CARE BUT REQUIRE ADDITIONAL SKILLED CARE. THE HOSPITAL HAD 511 ADMISSIONS IN 2013, OF WHICH 69.5% WERE MEDICARE. THE INPATIENT AVERAGE DAILY CENSUS FOR THE YEAR WAS 5.7 AND THE ACUTE AVERAGE LENGTH OF STAY WAS 3 DAYS.

NORTH CANYON MEDICAL CENTER'S EMERGENCY DEPARTMENT IS STAFFED 24 HOURS A DAY. ON AVERAGE, AN EMERGENCY SPECIALIST WILL SEE YOU WITHIN 15 MINUTES. OUR TEAM OF EMERGENCY SPECIALISTS ARE TRAINED IN ADVANCED CARDIAC LIFE SUPPORT, PEDIATRIC LIFE SUPPORT, AND ADVANCED TRAUMA LIFE SUPPORT. IN THE EVENT A PATIENT NEEDS AN EMERGENT TRANSFER TO ANOTHER FACILITY, NCMC UTILIZES A WIDE RANGE OF GROUND AND AIR MEDICAL TRANSPORT PROGRAMS. IN 2013, THE HOSPITAL HAD 4,654 VISITS TO ITS EMERGENCY DEPARTMENT.

NCMC PROVIDES A WIDE RANGE OF HEALTHCARE SERVICES IN TECHNOLOGICALLY ADVANCED FACILITIES. SERVICES INCLUDE OTOLARYNGOLOGY (ENT), GASTROINTESTINAL (GI), ORTHOPEDICS, GYNECOLOGY, GENERAL SURGERY, PAIN MANAGEMENT, AND UROLOGY. NORTH CANYON FITNESS AND REHABILITATION CENTER IS THE REHABILITATION SERVICES DEPARTMENT OF NCMC. OUR REHABILITATION SERVICES ARE PROVIDED BY TRAINED, LICENSED PROFESSIONALS WHO SPECIALIZE IN PHYSICAL, AQUATIC, OCCUPATIONAL, AND SPEECH THERAPY. WE PROVIDE INPATIENT THERAPY AT NCMC AND OUTPATIENT THERAPY AT THE NCMC FITNESS AND REHABILITATION CENTER. ADDITIONAL SERVICES PROVIDED BY NCMC INCLUDE NUTRITION SERVICES, A SPECIALTY CLINIC, AND A DURABLE MEDICAL EQUIPMENT LICENSE SO THE HOSPITAL CAN PROVIDE EQUIPMENT TO PATIENTS FOR THEIR HOME USE. NCMC PROVIDES CARE TO PERSONS COVERED BY GOVERNMENTAL PROGRAMS AT BELOW COST AND TO INDIVIDUALS WHO ARE UNABLE TO PAY. THE UNREIMBURSED VALUE OF PROVIDING CARE TO THESE PATIENTS WAS \$286,012 FOR CHARITY CARE, \$5,133,168 FOR MEDICARE, \$1,254,933 FOR MEDICAID, AND \$3,977,230 FOR OTHER THIRD PARTY PAYORS FOR THE YEAR.



Management's Discussion and Analysis
September 30, 2013 and 2012**

Our discussion and analysis of Gooding County Memorial Hospital District and Partners in Healthcare, Inc. doing business as North Canyon Medical Center's (the Organization) financial performance provides an overview of the Organization's financial activities for the fiscal years ended September 30, 2013 and 2012. Please read it in conjunction with the Organization's combined financial statements, which begin on page 8.

Financial Highlights

- The Organization's net position decreased by \$951,612, or 10.0%, in 2013 and increased by \$749,686, or 8.6%, in 2012.
- The Organization reported operating income of \$47,705 in 2013 and operating income of \$1,820,122 in 2012. Operating income in 2013 decreased by \$1,754,417, or 97.4%, from 2012. Operating income in 2012 increased by \$424,502, or 30.8%, over the income reported in 2011.
- Nonoperating revenues increased by \$17,641, or 2.3%, in 2013 compared to 2012. Nonoperating revenues increased by \$13,949, or 1.8%, in 2012 compared to 2011.

Using This Annual Report

The Organization's combined financial statements consist of three statements — the Combined Balance Sheets, the Combined Statements of Revenues, Expenses, and Changes in Net Position, and the Combined Statements of Cash Flows. These combined financial statements and related notes provide information about the activities of the Organization, including resources held by the Organization but restricted for specific purposes by contributors, grantors, or enabling legislation.

The Combined Balance Sheets and Combined Statements of Revenues, Expenses, and Changes in Net Position

Our analysis of the Organization's finances begins on page 4. One of the most important questions asked about the Organization's finances is, "Is the Organization as a whole better or worse off as a result of the year's activities?" The Combined Balance Sheets and the Combined Statements of Revenues, Expenses, and Changes in Net Position report information about the Organization's resources and its activities in a way that helps answer this question. These combined statements include all restricted and unrestricted assets and all liabilities using the accrual basis of accounting. All of the current year's revenues and expenses are taken into account regardless of when the cash is received or paid.

These two combined statements report the Organization's net position and changes in them. You can think of the Organization's net position — the difference between assets and liabilities — as one way to measure the Organization's financial health, or financial position. Over time, increases or decreases in the Organization's net position are one indicator of whether its financial health is improving or deteriorating. You will need to consider other nonfinancial factors, however, such as changes in the Organization's patient base and measures of the quality of service it provides to the community, as well as the local economic factors to assess the overall health of the Organization.

The Combined Statements of Cash Flows

The final required statements are the Combined Statements of Cash Flows. The combined statements report cash receipts, cash payments, and net changes in cash resulting from operations, investing, and financing activities. It provides answers to such questions as "Where did cash come from?", "What was cash used for?", and "What was the change in cash balance during the reporting period?"

The Organization's Net Position

The Organization's net position is the difference between its assets and liabilities reported in the Combined Balance Sheets on pages 8 and 9. The Organization's net position decreased by \$951,612, or 10.0%, in 2013 and increased by \$749,686, or 8.6%, in 2012, as shown in Table 1.

Significant components of the change in the Organization's assets are the increases in depreciation of capital assets of \$2,828,119, resulting in a decrease of capital assets of \$2,581,834. Other long-term assets increased \$2,348,995, of which \$1,969,252 was a result of a purchase of long-term investments. Cash and cash equivalents decreased by \$218,849 in 2013. The combination of these three changes of \$451,688 comprises the majority of the change in total assets of \$906,507 in 2013.

Operating Income (Loss)

The first component of the overall change in the Organization's net position is its operating income. The Organization has reported an operating gain of \$47,705 in 2013, and an operating gain of \$1,802,122 in 2012. This is not consistent with the Organization's entire operating history. The Organization's hospital operations began in 1987 as a municipal hospital, when it was agreed that a portion of its costs would be subsidized by property tax revenues, allowing the facility to offset bad debt and charity care costs. The operating gain in 2013 decreased by \$1,754,417, or 97.4%, from 2012. The operating gain in 2012 increased by \$424,502, or 30.8%, over the gain reported in 2011.

The components of the decreased operating gain are the decrease in net patient service revenue of \$419,470, or 3%, in 2013, and the increase in total operating expenses of \$1,154,017. Net patient service revenue increased by \$2,242,859, or 16%, in 2012.

The Organization's primary insurance payer is Medicare. The percent of total gross patient revenue from 2012 to 2013 for Medicare decreased from 50% to 45%. The decrease was primarily due to the reduction in Medicare patient days from 1,710 in 2012 to 1,576 in 2013. The increase in the aggregate contractual allowances from 35.1% in 2012 to 36.4% in 2013 is directly associated with this decrease in reimbursement rates from Medicare.

Employee salary and benefits costs increased by \$271,884, or 4.4%, in 2013. In 2012, they increased by \$685,090, or 12.5%. This increase was primarily due to annual merit increases and market adjustments from year to year. FTEs (full-time equivalents) from 2012 to 2013 decreased by 10 from 109 to 99. The calculation of FTEs changed from Paid FTEs to Worked FTEs. Had the calculation been consistent from prior year, total FTEs in 2013 would have been 112.

The rate of healthcare inflation has a direct effect on the cost of services provided by the Organization. A component of the Organization's costs is expenses for medical supplies and prescription drugs. In 2013, medical supplies and prescription drug costs totaled approximately \$1.8 million, or 10.7% of total operating expenses and an increase of 6.6% over 2012. The major factor contributing to the 6.6% increase in medical supplies and prescription drug costs in 2013 was the dispensing of one particular pharmaceutical drug, which had total costs of approximately \$129,000.

The Organization sometimes provides care for patients who have little or no health insurance or other means of repayment. As discussed, this service to the community is consistent with the goals established for the Organization when it was established in 1987. The level of services provided to these patients decreased by \$74,650 in 2013 compared to an increase by \$165,382 in 2012. The decrease was primarily due to the resistance of five patients to fill out the necessary charity care paperwork. The total cost of these five patients' write offs to bad debt was approximately \$106,000. Because there is no expectation of repayment, charity care is not reported as patient service revenues of the Organization.

Nonoperating Revenues and Expenses

Nonoperating revenues consist primarily of property taxes levied by the Organization and grants and contributions. Tax revenue funded by the Gooding County Memorial Hospital District totaled \$782,917 and \$759,418 in 2013 and 2012, respectively. The District began operations in 1918 as a county hospital and in 1987 converted to a government district hospital. Both as a county and district hospital it was understood that a portion of its costs would be subsidized by property tax revenues, making services accessible to the County's lower income residents.

Grants, Contributions, and Endowments

The Organization receives both capital and operating grants from various state and federal agencies for specific programs. These are discussed in detail in Note 1(b) to the combined financial statements. Grants received in 2013 totaled \$181,409 of which \$103,765 were classified as capital grants.

The Organization's Cash Flows

Cash and cash equivalents decreased in 2013 by \$181,409 from 2012. This decrease was primarily the result of funding the loss for the year.

One change in the composition of cash flows was the purchase of investments for \$2.0 million. This investment is included in the noncurrent assets section of the balance sheet. This investment is primarily made up of AAA-rated or better corporate bonds.

Capital Asset and Debt Administration

Capital Assets

At the end of 2013, the Organization had \$21.5 million invested in capital assets, net of accumulated depreciation, as detailed in Note 7 to the combined financial statements. In 2013, the Organization purchased new capital assets costing \$246,285. In 2012, the Organization purchased new capital assets costing \$337,988. The Organization does not anticipate significant capital additions during fiscal year 2014.

Debt

At year end, the Organization had \$24,305,329 in mortgage note payable. The Organization incurred no additional debt in 2013 or 2012.

Other Economic Factors

The Organization is located in a small rural community that has an agriculture-based economy. Like many small rural communities, economic and population growth is slight at best, if not declining. At this time, changes in the area economy are more realignments within agriculture such as larger but fewer farms and dairies, with the consequence being fewer people consuming healthcare services. In summary, the Organization is not located in a robust economic environment. Increase in hospital service revenue will likely be more the result of added or enhanced services, rather than increased volume through population growth. There are two other hospitals within a 50-mile radius. One is a brand new replacement facility with 186 beds and is a referral hospital for the area. The other hospital is also a Critical Access Hospital which provides surgical and obstetrical services, of which obstetrical is not available at this organization. The Organization is the only independent hospital in this 50-mile radius.

1. Reporting Entity and Summary of Significant Accounting Policies:

The combined financial statements include the accounts of Gooding County Memorial Hospital District (the District), and its component unit, Partners in Healthcare, Inc. doing business as North Canyon Medical Center (PIH), collectively referred to as the Organization. These combined financial statements have been prepared in conformity with accounting principles generally accepted in the United States of America, as applied to government units. The significant accounting policies of the Organization are described below.

a. Reporting Entity

Gooding County Memorial Hospital District is the primary government taxing entity. Partners in Healthcare, Inc. doing business as North Canyon Medical Center owns and operates a 15-bed critical access hospital located in Gooding, Idaho. The District is empowered to levy property taxes to sustain PIH's operations. The District also reviews how PIH utilizes taxes received from the District. The District is not a component unit of another reporting entity and is under no continuing obligation to distribute property taxes to PIH, unless a two-thirds majority vote is reached. The Board of Trustees consists of seven community members elected to seven-year terms.

The accompanying combined financial statements include the activities of the District and its component unit, PIH. The District maintains control over PIH through a majority voting member position of the Board of Directors. Generally accepted accounting principles provide guidance to determine whether certain organizations should be reported as a component unit based on the nature and significance of the relationship. The District has determined that PIH meets this definition for inclusion in the District's financial statements as a blended component unit. PIH's fiscal year ends on September 30 and the accompanying financial statements include financial information for its fiscal years ended September 30, 2013 and 2012. Although it is a separate legal entity from the District, PIH is reported as if it were part of the primary government because of control features contained within the bylaws of PIH.

b. Summary of Significant Accounting Policies

Enterprise fund accounting – The District's accounting policies conform to accounting principles generally accepted in the United States of America as applicable to proprietary funds of governments. The District uses enterprise fund accounting. Revenue and expenses are recognized on the accrual basis using the economic resources measurement focus.

Use of estimates – The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements. Estimates also affect the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Cash and cash equivalents – Cash and cash equivalents include highly liquid investments with an original maturity of three months or less

Inventories – Inventories are stated at lower of cost (first-in, first-out) or market. Inventories consist of pharmaceutical, medical-surgical, and other supplies used in the Organization's operations

Deferred financing costs and interest rate buy-down – Deferred financing costs are amortized over the term of the related obligation, which is 25 years, using a straight-line method. The interest rate buy-down costs are amortized over the term of the related obligation, which is 25 years, using the effective interest method. Amortization began on September 1, 2010, when the construction note payable converted to a permanent loan financing as provided for in the loan agreement

Capital assets – Capital asset acquisitions in excess of \$5,000 are capitalized and recorded at cost. Donated capital assets are stated at estimated fair value at the date of donation. Depreciation is provided over the estimated useful life of each depreciable asset and computed on the straight-line method. The estimated useful lives of capital assets are as follows

Land improvements	5-25 years
Buildings and fixed equipment	5-40 years
Major movable equipment	3-20 years

Compensated absences – The Organization's employees earn paid time off and sick leave at varying rates depending on years of service. Paid time off and sick leave accumulate up to a specified maximum depending on length of service. Employees are paid for accumulated paid time off upon termination. Sick leave accumulated is forfeited upon termination. Paid time off is accrued as earned. Sick leave is expensed when taken.

Net position – Net position is presented in the following three components

Net investment in capital assets – Net investment in capital assets consists of capital assets, net of accumulated depreciation and reduced by the current balances of any outstanding debt used to finance the purchase or construction of those assets

Restricted net position – Restricted net position is composed of assets that must be used for a particular purpose, as specified by creditors, grantors, or contributors external to the Organization, including amounts deposited with Trustees as required by bond indentures

Unrestricted net position – Unrestricted net position is composed of the remaining net position that does not meet the definition of net investment in capital assets or restricted net position

Operating revenues and expenses – The Organization's combined statements of revenues, expenses, and changes in net position distinguish between operating and nonoperating revenues and expenses. Operating revenues result from exchange transactions associated with providing healthcare services – the Organization's principal activity. Nonexchange revenues, including taxes, investment income, grants, and contributions received for purposes other than capital asset acquisition, are reported as nonoperating revenues. Operating expenses are expenses incurred to provide healthcare services, other than financing costs

Grants and contributions – From time to time, the Organization receives grants from the state of Idaho as well as contributions from individuals and private organizations. Revenues from grants and contributions (including contributions of capital assets) are recognized when all eligibility requirements, including time requirements, are met. Grants and contributions may be restricted for either specific operating purposes or capital purposes. Grants that are unrestricted or that are restricted to a specific operating purpose are reported as operating revenue. Grants that are used to subsidize operating deficits are reported as nonoperating revenue. Contributions, except for capital contributions, are reported as nonoperating revenue. Amounts restricted to capital acquisitions are reported after nonoperating revenues and expenses

Restricted resources – When the Organization has both restricted and unrestricted resources available to finance a particular program, it is the Organization's policy to use restricted resources before unrestricted resources

Income taxes – The Organization's component unit, PIH, has been determined to be exempt from federal income taxes under Section 501(c)(3) of the Internal Revenue Code. Accordingly, no provision for income tax is necessary. The Organization evaluates uncertain tax positions whereby the effect of the uncertainty would be recorded if the outcome was considered probable and reasonably estimable. As of September 30, 2013 and 2012, the Organization had no uncertain tax positions requiring accrual

Subsequent events – The Organization has evaluated subsequent events through January 15, 2014, the date on which the combined financial statements were available to be issued

2. Recent Accounting Pronouncements

In November 2010, the GASB issued Statement No 61, *The Financial Reporting Entity Omnibus*. This statement, which is effective for financial statements for periods beginning after June 15, 2012, provides, among other things, additional guidance to primary governments that are business-type activities reporting financial information in a single column. New guidance, which includes reporting a blended component unit, allows users to better distinguish between the primary government and its component unit by requiring condensed combining information in the notes to the financial statements. The Organization adopted GASB Statement No 61 during 2013, with no material affect on the Organization's financial statements

In December 2010, the GASB issued Statement No 62, *Codification of Accounting and Financial Reporting Guidance Contained in Pre-November 30, 1989 FASB and AICPA Pronouncements*. This statement, which is effective for financial statements for periods beginning after December 15, 2011, supersedes GASB Statement No 20. The Organization adopted GASB Statement No 62 during 2013, and its provisions were applied retroactively for all periods presented. Adoption of GASB Statement No 62 did not materially affect the Organization's financial statements

In June 2012, the GASB issued Statement No 63, *Financial Reporting of Deferred Outflows of Resources, Deferred Inflows of Resources, and Net Position*, which establishes standards for reporting deferred outflows and deferred inflows of resources and net position. The statement requires reporting of deferred outflows of resources (consumption of net assets applicable to future periods) and deferred inflows of resources (acquisition of net assets applicable to future periods) in separate sections of the balance sheet following assets and liabilities. The difference between assets plus deferred outflows of resources less liabilities plus deferred inflows of resources equals net position and net position should be displayed in three components as net investment in capital assets, restricted, and unrestricted. GASB Statement No 63 is effective for financial statement periods beginning after December 15, 2011. The Organization adopted the provisions of the statement in 2013 on a retroactive basis by reclassifying certain balance sheet elements for all periods presented. The adoption of GASB Statement No 63 did not materially affect the Organization's financial statements

In March 2011, the GASB issued Statement No 65, *Items Previously Reported as Assets and Liabilities*. GASB Statement No 65, which is effective for financial statements for periods beginning after December 15, 2012, amends or supersedes accounting and financial reporting guidance for certain items previously reported as assets or liabilities. The Organization will adopt GASB Statement No 65 in 2014 by retroactively restating financial statements for all periods presented. Debt issuance costs will need to be expensed as incurred when this standard is implemented

3. Bank Deposits and Investments:

Custodial Credit Risk

Custodial credit risk is the risk that in the event of a depository institution failure, the Organization's deposits may not be returned to it. The Organization does not have a deposit policy for custodial credit risk. At September 30, 2013 and 2012, the Organization had uncollateralized deposit balances of \$5,141,172 and \$409,074, respectively.

Investments

State statutes limit the investments in bonds, debentures, or notes of any corporation to be rated "A" or higher by nationally recognized statistical rating organizations.

Interest rate risk – This is the risk that changes in market interest rates will adversely affect the fair value of an investment. Generally, the longer the maturity of an investment, the greater the sensitivity of its fair value to changes in market interest rates. The Hospital does not have a formal investment policy that limits investment maturities as a means of managing its exposure to fair value losses arising from increasing interest rates.

4. Patient Accounts Receivable:

Patient accounts receivable are reduced by an allowance for uncollectible accounts. In evaluating the collectibility of patient accounts receivable, the Organization analyzes its past history and identifies trends for each of its major payor sources of revenue to estimate the appropriate allowance for uncollectible accounts and provision for bad debts. Management regularly reviews data about these major payor sources of revenue in evaluating the sufficiency of the allowance for uncollectible accounts. For receivables associated with services provided to patients who have third-party coverage, the Organization analyzes contractually due amounts and provides an allowance for uncollectible accounts and a provision for bad debts, if necessary (for example, for expected uncollectible deductibles and copayments on accounts for which the third-party payor has not yet paid, or for payors who are known to be having financial difficulties that make the realization of amounts due unlikely). For receivables associated with self-pay patients (which includes both patients without insurance and patients with deductible and copayment balances due for which third-party coverage exists for part of the bill), the Organization records a significant provision for bad debts in the period of service on the basis of its past experience, which indicates that many patients are unable or unwilling to pay the portion of their bill for which they are financially responsible. The difference between the standard rates (or the discounted rates if negotiated) and the amounts actually collected after all reasonable collection efforts have been exhausted is charged off against the allowance for uncollectible accounts.

The Organization's allowance for uncollectible accounts for self-pay patients has not changed significantly from the prior years. The Organization's provisions for bad debt and writeoffs have not changed significantly from the prior year. The Organization has not changed its charity care or uninsured discount policies during fiscal years 2013 or 2012. The Organization does not maintain a material allowance for uncollectible accounts from third-party payors, nor did it have significant writeoffs from third-party payors.

5. Electronic Health Records Incentive Payment:

The Organization recognized Medicare and Medicaid electronic health records (EHR) incentive payments of \$32,625 and \$296,318 during the years ended September 30, 2013 and 2012, respectively. The EHR incentive payments are provided to incent hospitals to become meaningful users of EHR technology, not to reimburse providers for the cost of acquiring EHR assets. EHR incentive payments are therefore reported as operating revenue.

The Organization recognizes the Medicare incentive payment on the date that the Organization has successfully complied with meaningful use criteria during the entire EHR reporting period. The Organization first attested to meaningful use with Centers for Medicare and Medicaid Services (CMS) during 2011. The Medicare EHR reporting period is through September 30 of each year.

The Medicare incentive payment recognized is an estimate and subject to audit by CMS. The Medicare EHR incentive payment is based on the days reported in the prior year Medicare cost report and the undepreciated cost of the EHR equipment submitted to CMS. The final payment will be based on the days reported in the current Medicare cost report. Medicare incentive payments of \$0 and \$11,333 were recognized as revenue in 2013 and 2012, respectively.

The Organization recognized the first of its three Medicaid incentive payments during 2012. Medicaid incentive payments of \$32,625 and \$284,985 were recognized as revenue in 2013 and 2012, respectively.

6. Property Taxes:

The County Treasurer acts as an agent to collect property taxes levied in the County for all taxing authorities. Under Idaho law, all property taxes become due and payable in the year following that in which they are levied. Property taxes are levied annually on November 1 on property values assessed as of January 1 of the same year. Tax levy notices are issued in November and payments are due on December 20 and June 20. The billings are considered past due one day after the respective payment dates, at which time penalties and interest are assessed.

Assessed values are established by the County Assessor at 100% of fair market value. A revaluation of all property is required every five years. Property taxes are recorded as receivables when levied. Since state law allows for sale of property for failure to pay taxes, no estimate of uncollectible taxes is made.

Collections are distributed monthly to the Organization by the County Treasurer. The Organization is permitted by law to levy up to a 3% increase over the highest levy amount for the previous three years plus an additional \$0.77 per \$1,000 of assessed new construction property valuation. The Organization's property tax levy was \$0.79 and \$0.79 per \$1,000 on a total assessed valuation of \$914,190,178 and \$879,652,727 for a total levy of \$719,361 and \$692,184 in 2013 and 2012, respectively.

8. Long-Term Debt (continued):

The terms and due dates of the Organization's long-term debt at September 30, 2013 and 2012, are as follows

The mortgage note payable was entered into by the Organization for the construction of a new hospital facility. The total amount borrowed on the note was \$26,799,300. The note bears interest at 6.75%. The Organization made monthly interest only payments during the construction period. Payments on the permanent loan commenced in September 2010 with a term of 25 years, maturing in August 2035. Monthly interest and principal payments on the permanent loan are \$185,159. The note is secured by a mortgage on the new hospital facility and is insured by the U.S. Department of Housing and Urban Development (HUD) under Section 242 of the National Housing Act.

The terms of the loan require monthly deposits to a mortgage reserve fund through 2020. The required balance in the mortgage reserve fund at September 30, 2013 and 2012, was \$1,094,735 and \$658,297, respectively. The reserve fund is available for debt payments by the approval of HUD.

In addition, the note also places limits on the incurrence of additional borrowings and requires the Organization to satisfy certain measures of financial performances and reporting requirements as long as the note is outstanding. As of September 30, 2013, the Organization had complied with the required covenants.

9. Net Patient Service Revenue:

The Organization recognizes patient service revenue associated with services provided to patients who have third-party pay or coverage on the basis of contractual rates for the services rendered. For uninsured patients that do not qualify for charity care, the Organization recognizes revenue on the basis of its standard rates for services provided (or on the basis of discounted rates, if negotiated or provided by policy). On the basis of historical experience, a significant portion of the Organization's uninsured patients will be unable or unwilling to pay for the services provided. Thus, the Organization records a significant provision for bad debts related to uninsured patients in the period the services are provided. Patient service revenue, net of contractual allowances and discounts (but before the provision for bad debts), recognized in the period from these major payor sources, is as follows:

The Organization has agreements with third-party payors that provide for payments at amounts different from its established rates. A summary of the payment arrangements with major third-party payors follows:

- *Medicare* – The Organization has been designated a critical access hospital by Medicare and is reimbursed for inpatient and outpatient services on a cost basis as defined and limited by the Medicare program. The Organization is reimbursed for cost reimbursable items at a tentative rate with final settlement determined after submission of annual cost reports by the Organization and audits thereof by the Medicare administrative contractor. Physician services are reimbursed on a fee schedule.
- *Medicaid* – Inpatient and outpatient services rendered to Medicaid program beneficiaries are reimbursed on a cost basis as defined by the state of Idaho subject to certain limitations. The Organization is reimbursed at a tentative rate with final settlement determined after submission of annual cost reports by the Organization and audits thereof by the Medicaid fiscal intermediary. Physician services are reimbursed on a fee schedule.

9. Net Patient Service Revenue (continued):

- *Other* – The Organization has also entered into payment agreements with certain commercial insurance carriers and other organizations. The basis for payment to the Organization under these agreements includes prospectively determined rates per discharge, discounts from established charges, and prospectively determined daily rates

Laws and regulations governing the Medicare, Medicaid, and other programs are extremely complex and subject to interpretation. As a result, there is at least a reasonable possibility that recorded estimates will change by a material amount in the near term. Net patient service revenue for the year ended September 30, 2013, increased approximately \$218,000 due to changes in estimates and final settlements of prior years cost reports. Net patient service revenue for the year ended September 30, 2012, decreased approximately \$150,000 due to changes in estimates and final settlements of prior years cost reports.

The Organization provides charity care to patients who are financially unable to pay for the healthcare services they receive. The Organization's policy is not to pursue collection of amounts determined to qualify as charity care. Accordingly, the Organization does not report these amounts in net operating revenues or in the allowance for doubtful accounts. The Organization determines the costs associated with providing charity care by aggregating the applicable direct and indirect costs, including salaries, wages and benefits, supplies, and other operating expenses, based on data from its costing system. The costs of caring for charity care patients for the years ended September 30, 2013 and 2012, were approximately \$183,000 and \$218,000, respectively.

10. Deferred Compensation Plan:

The Organization provides employees with a deferred compensation pension plan in accordance with Internal Revenue Code Section 403(b). The Partners in Healthcare, Inc. 403(b) Retirement Plan (the 403(b) Plan) is a defined contribution plan and is available to eligible Organization employees who have completed three months of service and permits them to defer a portion of their salary until withdrawn in future years. The deferred compensation is not available to employees until termination, retirement, death, or unforeseeable emergency.

The Organization also provides employees with a deferred compensation pension plan in accordance with Internal Revenue Code Section 401(a). The Partners in Healthcare, Inc. Retirement Plan (the Plan) is a defined contribution plan and is available to eligible Organization employees who have met the requirements of the 403(b) Plan and have elective deferrals to that plan. The Organization contributes \$1 for each \$1 the employees contribute up to 6% of deferred compensation.

The Organization's contributions vest evenly over a five-year period from the employee's date of entry into the 403(b) Plan. The 403(b) Plan participants contributed approximately \$154,000 and \$148,000 to the plan for the years ended September 30, 2013 and 2012, respectively. The Organization contributed approximately \$105,000 and \$92,000 to the Plan for the years ended September 30, 2013 and 2012, respectively.

10. Deferred Compensation Plan (continued):

The assets for the 403(b) Plan and the Plan are invested within various fund pools established and maintained by the Variable Annuity Life Insurance Company. The 403(b) Plan and the Plan are administered by the Organization. The Organization may amend the provisions of the plans at its discretion.

11. Healthcare Self Insurance:

The Organization partially self-insures the cost of employee healthcare benefits. The Organization self-insures the first \$50,000 in claims per eligible participant. The Organization also purchases annual stop-loss insurance coverage for all claims in excess of \$50,000 per participant. Liabilities on the balance sheets include an accrual for claims that have been incurred but not reported. Claims liabilities are re-evaluated periodically to take into consideration recently settled claims, frequency of claims, and other economic and social factors.

12. Concentration of Credit Risk:

Receivables – The Organization grants credit without collateral to its patients, most of who are local residents and are insured under third-party payor agreements. The majority of these patients are geographically concentrated in and around Gooding County.

Physicians – The Organization is dependent on local physicians practicing in its service area to provide admissions and utilize hospital services on an outpatient basis. A decrease in the number of physicians providing these services or change in their utilization patterns may have an adverse effect on hospital operations.

13. Commitment and Contingencies:

Risk management – The Organization is exposed to various risks of loss from torts, theft of, damage to, and destruction of assets, business interruption, errors and omissions, employee injuries and illnesses, natural disasters, and employee health, dental, and accident benefits. Commercial insurance coverage is purchased for claims arising from such matters. Settled claims have not exceeded this commercial coverage in any of the three preceding years.

Medical malpractice claims – The Organization obtains medical malpractice insurance through Washington Casualty Company (WCC). WCC offers the Organization a professional and general liability policy on a “claims made” basis with primary limits of \$2,000,000 per claim and an annual aggregate limit of \$6,000,000. The policy has no deductible. The renewal date of the policy is August 1, 2014.

Litigation – The Organization is subject to the usual contingencies in the normal course of operations relating to the performance of its tasks under its various programs. In the opinion of management, the ultimate settlement of litigations, claims, and disputes in process will not be material to the financial position of the Organization.

13. Commitment and Contingencies (continued):

Industry regulations – The healthcare industry is subject to numerous laws and regulations of federal, state, and local governments. Compliance with these laws and regulations, specifically those relating to the Medicare and Medicaid programs, can be subject to government review and interpretation, as well as regulatory actions unknown and unasserted at this time. Federal government activity has increased with respect to investigations and allegations concerning possible violations by healthcare providers of regulations, which could result in the imposition of significant fines and penalties, as well as significant repayments of previously billed and collected revenues from patient services. Management believes that the Organization is in substantial compliance with current laws and regulations.

Healthcare reform – As a result of recently enacted federal healthcare reform legislation, substantial changes are anticipated in the United States of America's healthcare system. Such legislation includes numerous provisions affecting the delivery of healthcare services, the financing of healthcare costs, reimbursement of healthcare providers, and the legal obligations of health insurers, providers, and employers. These provisions are currently slated to take effect at specified times over approximately the next decade. The federal healthcare reform legislation does not affect the 2013 financial statements.

14. Related-Party Transactions:

St Luke's Health System (St Luke's) maintains 16% of the voting power of the Organization's Board of Directors. The Organization has a management services agreement (Agreement) with St Luke's. The agreement gives St Luke's, through the Administrator/CEO, full authority to implement and fulfill the policy decisions of the Board of Directors. The Agreement may be terminated by mutual agreement of both parties at any time.

During the years ended September 30, 2013 and 2012, the Organization purchased approximately \$949,000 and \$594,000, respectively, in services from St Luke's.

The Organization's aggregated future commitment related to the management services agreement is approximately \$226,000.

In our opinion, except for the noncompliance described in the Basis for Qualified Opinion paragraph, the Organization complied, in all material respects, with the types of compliance requirements referred to above that could have a direct and material effect on the U.S. Department of Housing and Urban Development Mortgage Insurance – Hospitals federal program for the year ended September 30, 2013.

Other Matters

The Organization's response to the noncompliance finding identified in our audit is described in the accompanying corrective action plan. The Organization's response was not subjected to the auditing procedures applied in the audit of compliance and, accordingly, we express no opinion on the response.

Report on Internal Control Over Compliance

Management of the Organization is responsible for establishing and maintaining effective internal control over compliance with the types of compliance requirements referred to above.
