Breathe EASY - Home Improvement project
Breathe DC provided case management enhancement and referral services for 16 children at high risk of asthma attacks through initial home visit. We equipped three families of high-risk asthmatic children with a tailored smoking cessation action plan to measurably reduce children's exposure to tobacco smoke in the house.

Effi Barry-HIV/AIDS Capacity Building Program
During the project, focus groups were completed with HIV positive smokers to test messages and gather input on effective messages for HIV positive smokers. The case managers and other staff of our linkage partner Damien Ministries were trained by a Certified Tobacco Treatment Specialist, to provide tobacco education and support to their clients that are HIV positive smokers. Breathe DC conducted four smoking cessation classes with 37 Damien Ministries clients identified as HIV positive smokers. Breathe DC utilized the pre and post questionnaire results from the focus groups to develop a outreach plan for a sustainable cessation program.

Camp Breathe Happy
19 Campers attended Camp Breathe Happy during the summer of 2013. Campers consisted of children residing within the District of Columbia between the ages of 8-12 living with asthma. During the course of the program, several evaluation methods were used including, a sample of 19 campers who completed a pre and post-test, a pre and post-questionnaire for parents and a camp experience questionnaire. Evaluation results show that Camp Breathe Happy was successful in reaching the goal to increase asthma knowledge and management skills among campers that completed sessions. Camp participants were able to significantly increase their knowledge and understanding of various asthma related topics. The information gained through the program also lead to observable improvements in asthma management, as indicated by parent responses.
