| The organization has rescued large exotic cats, such as tigers, lions, leopards, and jaguars from all over North America. The animals' background ranges from former pets that can no longer be cared for, animals retired from the circus, surplus cats from zoos. By giving them a home, these animals are saved from euthanization. The organization provides medical care for the cats, and incorporates them into an educational program designed to educate the public about the plight of exotic cats. Thousands of individuals take part in guided tours of the refuge, where they have an opportunity to see and learn more about the exotic cats. School tours are also offered, with an educational program that can be tailored to fit ages from kindergarten to college. The organization also participates in DNA research with the goal of determining a genetic snapshot of tigers in the U.S., to be used to further develop conservation programs.
