AT THE TIME OF THE TRANSFER, THE AGENCY GRANTED VARIANCE POWER TO THE FOUNDATION. THAT POWER GIVES THE FOUNDATION THE RIGHT TO DISTRIBUTE THE ASSETS TO ANOTHER NOT-FOR-PROFIT ORGANIZATION OF ITS CHOICE IF THE AGENCY CEASES TO EXIST OR CEASES TO BE A QUALIFIED CHARITABLE ORGANIZATION. THE VARIANCE POWER GRANTED TO THE FOUNDATION ALLOWS THE AGENCY A 30-DAY PERIOD DURING WHICH IT MAY ADVISE THE FOUNDATION OF ITS VIEWS REGARDING THE PROPOSED EXERCISE OF THE POWER AND TAKE SUCH OTHER ACTION, AS IT DEEMS APPROPRIATE. THE FOUNDATION AGREES THAT IF ITS BOARD OF TRUSTEES PROPOSES TO EXERCISE THE VARIANCE POWER, THE EXERCISE OF SUCH POWER SHALL NOT BE EFFECTIVE EARLIER THAN AT LEAST 30 DAYS AFTER THE WRITTEN NOTICE TO THE AGENCY.
