RESOLUTION AMENDING ARTICLES AND BYLAWS

Whereas, the Board of Trustees of the Huron County Community Foundation wishes to amend the Articles of Incorporation and Bylaws of the Foundation to reflect changes in Board membership and tenure;

NOW THEREFORE, BE IT RESOLVED AS FOLLOWS:

ARTICLE VII OF THE ARTICLES OF INCORPORATION, CLASSIFICATION AND TENURE OF BOARD OF TRUSTEES, shall be and hereby is amended so that, as amended, it shall read in its entirety as follows:

A Trustee shall be appointed to a term of office of three years. A Trustee may serve a maximum of three terms, and then must be off the Board for a minimum of one year before serving again. A partial term of longer than two years shall be considered a full term. If a Trustee resigns before the expiration of his/her term, a new Trustee shall be appointed to fill out the remainder of the resigning Trustee's term. The Board of Trustees may stagger terms of office, as it may deem appropriate, so as to minimize the number of vacancies on the Board at the same time caused by the expiration of terms of office.


ARTICLE 1, SECTION 3 OF THE BYLAWS, TERM OF OFFICE AND VACANCIES, shall be and hereby is amended so that, as amended, it shall read in its entirety as follows:


A Trustee shall be appointed to a term of office of three years. Vacancies on the Board of Trustees are filled as provided in the Articles of Incorporation and in a manner as shall be determined, from time to time, by the Board of Trustees. A Trustee may serve a maximum of three terms and then must be off the Board for a minimum of one year before serving again. Officers serve for one year with election at the annual meeting in January.

BE IT FURTHER RESOLVED THAT this resolution and the amendments contained herein shall supersede and replace in their entirety those amendments contained in a similar resolution adopted by the Board of Trustees on May 6, 2009.

BE IT FURTHER RESOLVED THAT the Executive Director shall take all necessary action, file all necessary forms, and pay all necessary fees to effectuate this resolution.
