MARAMA administered five continuing grants offering support to reduce diesel emissions from dray trucks and vessels serving Mid-Atlantic ports and from construction equipment owned by small businesses. Projects completed during the year included retrofitting 16 dray trucks, replacing 122 dray trucks, and repowering 1 tug. MARAMA also organized four webinars for the Mid-Atlantic Diesel Collaborative. These webinars provided information on grants for diesel emissions reduction projects from the US Environmental Protection Agency and the US Department of Transportation, a new database for identifying appropriate diesel emissions controls, and the health and climate impacts of black carbon emissions. In early 2013, the Mid-Atlantic Regional Air Management Association, Inc. (MARAMA) launched an updated website for the Mid-Atlantic Diesel Collaborative, improving the site's functionality and broadening the information provided.

The Mid-Atlantic Regional Air Management Association, Inc. (MARAMA) helped member agencies develop and retain effective staff members by organizing and supporting technical training opportunities. MARAMA organized six in-person training courses on principles and practices of air pollution control, inspection procedures and safety, basic and advanced inspector training, air pollution control devices, and biomass-fired boilers. Two workshops organized by MARAMA provided advanced training on transportation and air quality as well as forecasting future emissions and air quality. Nine MARAMA webinars provided opportunities to learn about engine control technologies, project management, basic meteorology, mercury emissions and controls, new tools for forecasting electricity generating units (EGU) emissions, and Marcellus Shale oil and gas operations. Twenty-four MARAMA members also attended twelve national and regional conferences and meetings with support from MARAMA.

Leading development of emissions inventory data for regional air quality modeling, with support from committee members and contractors, the Mid-Atlantic Regional Air Management Association, Inc. (MARAMA) completed a trend analysis of air emissions between 2002 and projected year 2020. MARAMA's technical support for a 2025 inventory helped states assess emissions of fine particles affecting future air quality. MARAMA facilitated coordination between the US Environmental Protection Agency and state/local experts and provided technical support that improved estimates of emissions from oil and gas operations, electricity generating units (EGUs), residential wood combustion, and on-road mobile sources. MARAMA managed development of a new tool to forecast future emissions from EGUs and initiated development of a regional Emissions Modeling Framework (EMF) and Cost Strategy Tool (CoST). These new tools will significantly enhance members' ability to analyze 2007 and 2011 emissions inventory data and forecast future emissions affecting air quality and public health.
