High School Senior Scholarship recipients are selected each year by the administration of the community high schools. Scholarships are awarded to the students selected. The

scholarships are submitted directly to the college/trade school of the student's choice.

Student field trips are awarded upon requests submitted by teachers and principals through the Cedar Rapids Community School District (CRCSD).

Student Enrichment Fund Grants of up to \$100 are provided in the fall to teachers who apply through CRCSD to CRCSD for classroom-based funding.

Before/After Program grant underwrote educational enrichment classes and activities for students ages 3-7 conducted and monitored through the Grant Early Childhood Center.

SAFE Program is described in detail in Schedule O in response to Form 990, Part III, Question 4d. The programs are monitored by the CRCSD.

School Project Grants, ranging from \$500 to \$10,000, are provided in the spring to teachers for large capital needs. The projects are recommended and monitored by the CRCSD.

Professional Enrichment Grants are awarded to community school district educators, who submit application for assistance in furthering their educational development.

The Foundation serves as the fiscal agent for various programs that have a relationship with the CRCSD in various capacities. The Foundation receives contributions for these programs and dispenses the funds to support specific activities of the program's choosing within the CRCSD.

The SAFE program offers financial assistance for participation in extra-curricular activities to at-risk/low income students, and/or those students affected by the 2008 flood in Cedar Rapids and/or those students attending a school located in a flood-affected neighborhood.

The Board of Trustees has commissioned the Executive Committee and the Operations Committee, which includes the officers of the Board of Directors and the Executive Committee, to review and approve the form 990 prior to filing. Copies of the form 990 are also shared with the Board of Trustees, as per the recommendation of the Executive and Operations Committees.

A board member or committee member who is formally considering employment with CRCSD must take a temporary leave of absence until the position is filled. The request for temporary leave of absence must be in writing and submitted to the Board of Trustees for consideration and formal action.

An interested board member, officer, or staff member shall not participate in any discussion or debate of the Board of Trustees, or of any committee, subcommittee thereof in which the subject of discussion is a contract, transaction, or situation in which there may be a perceived or actual conflict of interest. However, such interested party may be present to provide clarifying information in such discussion or debate unless objected to by any present board or committee member.

Anyone in a position to make decisions about spending CRCSD resources, who stands to benefit from that decision, has a duty to disclose that conflict as soon as it arises (or becomes apparent). Such person should not participate in any final decisions regarding such transactions.

Any conflicts will be noted in minutes of meetings.
