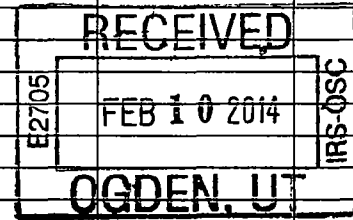

Part II, Line 13 - The other investments of the Foundation as of 9/30/2013 were two life insurance policies issued by the John Hancock Life Insurance Company (USA) insuring the life of Joan Abele (the “Policies”)—policy numbers 96086410 and 96086800. One Policy was issued initially to the Foundation; the other Policy was issued initially to Wilbert Abele, and was transferred by him to the Foundation in December 2012. No income-tax charitable contribution deduction was claimed for the transfer of this second Policy.

The face amount of each Policy is \$5 million, and the annual premium for each Policy is \$95,133.

As of 9/30/2013, the cash surrender value of each Policy was zero, but the “account value” of the Policy (*i.e.*, the full cash value of each Policy without taking surrender charges into account) was \$98,213.24. The Policies are not expected to have a cash surrender value until the third policy year (*i.e.*, the year beginning December 7, 2014).

Part III, Line 3 – This amount equals the increase in “account values” of the Policies which occurred during the year (*i.e.*, \$196,426.48 - \$52,670.00).

Part III, Line 5 - This amount equals the sum of (a) the premiums that were paid for the Policies during the year (*i.e.*, \$190,266.00) plus (b) a check for a contribution made by the Foundation which was subsequently returned uncashed (*i.e.*, \$1,296.87).
