Our monthly magazine focuses on information about trends, current planning practices, new approaches, reviews of books, reports, and events in both private and public sectors. The Journal of the American Planning Association is published quarterly to report on research, new thoughts, and current literature. It is edited independently through a university-based editorial team and has a worldwide subscription list. The Planning & Environmental Law periodical is published monthly and distills the latest court decisions and legislation regarding planning and environmental law. Every issue contains detailed abstracts of the most important new state and federal court decisions. The Zoning Practice periodical is published monthly and helps guide those who write and administer development codes, monitors all the latest trends in local land-use controls, and brings the reader current news and ordinance excerpts. Each quarter APA’s Planning Advisory Service (PAS) publishes a new PAS report providing authoritative guidance on current issues and innovative practices. The American Institute of Certified Planners’ (AICP) Certification Maintenance program helps certified planners gain the knowledge and skills they need to remain current in the practice of planning. Community Planning Assistance Teams (CPAT) are a key AICP initiative. Through this program, a multidisciplinary team of expert planning professionals is paired with community members, key stakeholders, and relevant decision makers in a place-based initiative to foster community education, engagement, and empowerment. Students participate, along with professional planners with the AICP credential, to provide pro bono services to communities.
