Age-In-Place assisted seniors to remain safely in their homes and in the community. Volunteer services mobilized 1,791 volunteers to provided free yard maintenace, heavy cleaning and painting services. Additional volunteers built one on one relationships with isolated seniors.

Age-In-Place: Volunteer Services provided over 7,317 hours of housing support to 296 seniors living in Washington, DC, primarily in Wards 4 and 5.
