South Park baseball continued to flourish in FY 2012 We had approximately 450 boys participate during our Spring and Fall leagues, which encompassed t-ball (ages 5 & 6), coach pitch (ages 7 & 8), minors (ages 9 & 10) majors (ages 11 & 12) and Babe Ruth (ages 13 - 16). In addition to the revenues noted above, baseball received approximately \$30,000 of contributions from companies & individuals to help finance our program All baseball coaches are volunteer parents who receive no compensation for their efforts. SPYA policy mandates that all coaches pass a background check on an annual basis in order to coach. Baseball teams are selected (drafted) each season subsequent to all players attending a skills day assessment, which helps ensure that our teams are as even as possible and creates fair competition.

4b (Code:) (Expenses \$ 81,487 including grants of \$ 0) (Revenue \$ 71,853)

In FY 2012, South Park football included 9 teams, or approximately 225 participants. Our football league was once again aligned with Pop Warner youth football, which requires kids to participate based on age and weight restrictions to help ensure safety for the kids. SPYA did provide several partial scholarships agains this year for players whose parents could not afford the regular participation fee All football coaches are volunteer parents who receive no compensation for their efforts. SPYA policy mandates that all coaches pass an annual background check in order to be eligible to coach.

4c (Code:) (Expenses \$ 66,588 including grants of \$ 0) (Revenue \$ 63,272)

South Park lacrosse almost tripled its participants in year 2 of its existance, going from approximately 70 kids to approximately 200 kids. In addition to the revenues noted above, lacrosse received approximately \$16,500 of contributions from companies and individuals to help finance our program Coaches for SPYA lacrosse teams include volunteer parents as well as individuals with college / pro lacrosse experience who receive a nominal amount of pay for their coaching activities SPYA policy mandates that all coaches pass an annual background check in order to coach. SPYA is now one of the largest youth lacrosse leagues in the city of Charlotte.
