Committee afterwards. The committee is provided hard data along with anecdotal reports each quarter as to all transactions.

Section IV. Line 21 and 22 - No organization was awarded over \$5000 and none of the colleges to which scholarships were applied did

either.

Section V. 1c - was left blank in that we had not such transactions but would have happily complied if we did.

Section VII - No members are compensated, the entity is entirely volunteer. We do reimburse well below the Federal limit for mileage when

meetings are not virtual. Reimbursement rate offered, and not all accept, is \$0.30 per mile.
