Our mission is to partner with communities in promoting the social-emotional health and well-being of children and families. This has been accomplished through the use of effective interventions, implemented in supportive and nurturing environments by well-trained staff.

The Parent-Child Center, Inc. (PCC), d/b/a Community Partners, is a nonprofit organization providing the Child & Family Mental Health Services of Community Partners' holistic approach to Changing the Odds for Palm Beach County's children and families facing adversity. Since beginning services in 1979, our program was widely recognized as the lead authority in caring for our most vulnerable children victims of trauma, abuse and neglect, among other childhood developmental, social, emotional and medical disorders. In our dedication to providing the highest-quality services, PCC directs an internship program for Masters and Bachelors level social work and mental health students, and received national accreditation from the Council on Accreditation (COA) in 2006. In order for every child to have their best chance at life, we know children need the basic support that ensures healthy physical and social-emotional development. Stable, nurturing relationships and a competent caregiver are the most important factors in helping children and families break free of crippling adversity. Most children and families receiving Child & Family Mental Health Services face multiple risk factors such as poverty, substance abuse, physical abuse, and mental illness. In 2013, more than 3600 children and families in Palm Beach County benefited from our outreach efforts, and over 1840 received direct, face-to-face services which include prevention and early intervention services as well as programs that focus on the reunification of families when a child has been removed from the home. Our objectives are met through eleven distinct programs providing essential mental health services for children and families that are individualized, strengths-based, recovery-oriented, and family-driven. Current programs include: -Intake and Assessment Services -Outpatient Child and Family Mental Health Services-0 to 5 and Infant Mental Health (A program focused on maternal/child bonding and healthy development)-Triple P Parenting (A parent skill training program)-School Intervention Services (Provides mental health intervention and services for homeless children and families)-Partners for Prevention (Designed to divert families from having DCF remove their children from the home)-Family Recovery Program (Provision of support to families who have had child(ren) removed from the home with the goal of swift reunification)-Targeted Case Management (Identification of primary basic needs and linkage to community resources for families receiving services from PCC) -Crossroads Independent Living (A program for young adults with mental health issues who come from the foster care system and/or who would be homeless) -Department of Juvenile Justice Mental Health Program (Designed to provide assessment and service provision to children entering the DJJ system with the goal of preventing re-offense) -Psychiatric Services (Evaluation for and ongoing management of psychiatric medication needs of children served through PCC programs) From the extensive offering above, our programs provide tremendous impact across the entire geographic area of Palm Beach County, including the far-western communities of Belle Glade and Pahokee, where our therapists mobilize into homes, schools, and community centers to reach client families. Our hub for services resides at our offices in Riviera Beach, serving the most concentrated population of vulnerable families.
