Housing Development. The Corporation builds new homes and rehabilitates existing homes that are made available for sale to first-time home buyers. In addition, the Corporation maintains an inventory of single family rental properties that are available for households who aspire to become a home purchaser and provides them with on-going counseling support that is intended to assist them to become "mortgage ready" for eventual home ownership. The Corporation also administers a variety of home repair assistance initiatives that directly benefit very low and lower-income owner-occupant households. The Corporation also operates neighborhood stabilization programs in Marion and Clay Counties. The Corporation purchases, rehabilitates and sells foreclosed homes through contracts with

Home Ownership Preservation. The Corporation supports participants in preserving their mortgage through tough economic times. The Corporation offers a Post-Purchase Program for recent homebuyers. Class topics include information on property maintenance, energy conservation, and household budgeting. The Corporation also provides intensive mortgage delinquency and foreclosure intervention counseling for home owners in financial distress. The Corporation's Counseling Services are one-on-one sessions with a staff professional that are tailored to meet the individual needs of the client. In addition to pre and post purchase questions, other topics include, but are not limited to, fair housing, predatory lending, and landlord tenant issues.

4c (Code) (Expenses \$ **103,433** including grants of \$ **5,756**) (Revenue \$)
Home Ownership Promotion. The Corporation actively promotes home ownership. They provide the Financial Fitness Program. This program is an eight hour course broken into four instructional segments that focus on 1) basic money matters, 2) budgeting, 3) credit repair, and 4) other financial topics. The class is intended for households that have a dream of home ownership but have credit or financial obstacles. The course is generally facilitated off-site through a partnership relationship with affiliate social service organizations and church groups. The Corporation also provides a Pre-Purchase Home Buyer Education Seminar designed to educate participants on the home purchase process.
