2-1-1 is a 24 hour a day, 365 days a year, contact center based service that assists individuals and families in navigating the complex and ever growing maze of health and human service providers, non-profit organizations, government agencies, and community service organizations 2-1-1 improves the way in which people learn about and connect with the services they need by providing access to comprehensive, up-to-date information at any time by phone or online at no cost to the caller 2-1-1 helps create new efficiencies in the delivery of health and human services by saving time for individuals seeking help, and eases the frustration of people searching for appropriate services for which they are eligible 2-1-1 also helps service providers do their jobs more easily, refers ever more callers to the right places, and reduces costly duplication of effort by other service providers by building and maintaining databases 2-1-1 serves as a resource for businesses and local employers by assisting their employees and helping to maintain productivity 2-1-1 supports stressed employees, decreases absenteeism and supports employee assistance programs 2-1-1 serves as a support system for emergency management by assisting before, during, and immediately after emergencies such as health crises, blackouts, natural disasters such as tornadoes and floods, or man-made crises such as terrorism events 2-1-1 is recognized by Pinellas County Government as the central telephone number for all health and human service information in the event of a disaster 2-1-1 provides trend data on health and human service needs (met and unmet) for planning and resource allocation Many times, data provided by 2-1-1 is the first place to see emerging needs and demands for existing services 2-1-1 data can be organized in a variety of ways, including geographically 2-1-1 is particularly helpful in mapping relative locations of high areas of needs and locations of resources As a result, 2-1-1 contributes to better use of scarce resources, including both tax dollars and chantage contributions 2-1-1 connects people with opportunities to "give help" as well as "get help " 2-1-1 provides an easy to remember number for individuals interested in volunteering to call and be directed to various volunteer projects in the community In this last fiscal year (October 1, 2012 - September 30, 2013), highly trained 2-1-1 contact center staff handled 96,173 calls (72,099 live calls and 24,074 Information Boxes), 1,222 emails and 481 live on-line chats from local residents seeking assistance 2-1-1 served the population of greatest needs 57 1% of calls benefit children, and of those calls 43 8% benefit children under five years old Last year, 2-1-1 made 120,075 referrals to community partners about 88,730 needs identified The types of 2-1-1 contact center need requests by percentage include 42% housing and utilities assistance, 17% individual, family, and community support, 8% food and meals, 6% mental health and addictions, 6% clothing, personal and household needs, 5% legal, consumer and public safety services, 5% health care, 3% transportation, 3% income support and assistance, 3% education, and 2% other (includes arts, culture, recreation, employment, volunteers, donations, disaster, government and economic services) In the same period, 633 of these calls were suicide prevention related and 535 were sexual assault related 2-1-1 continues to provide intensive support and in some instances life-saving assistance to callers in need of immediate intervention

Tampa Bay Information Network (TBIN) is a program that provides the administration of an automated network consisting of client-level-data for Pinellas County's homeless and in-peril populations Thirty health and human service agencies participate in this client management software system which includes 132 programs and 315 system users (health and human service professionals) Additional TBIN staff provide the overall administration, training and report generation support for this network system and the Pinellas Homeless Leadership Board TBIN has been operated by 2-1-1 TBC for 11 years As a "best practices" U S Department of Housing and Urban Development mandated project, the TBIN program, is an integral part of the Pinellas County's Continuum of Care directed by the Pinellas Homeless Leadership Board
