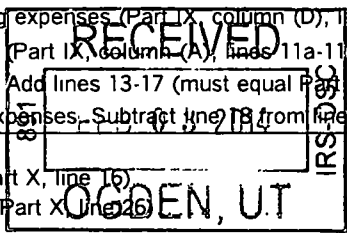

The next quarter's distributions are not sent unless the previous quarterly report has been received.
