Through the fundraising efforts of the Foundation, donations are made and allocated to the U.S. Space & Rocket Center for scholarships to attend Space Camp and other educational museum programs. Space Camp and affiliated programs provide hands on learning of Science, Technology, Engineering, and Math (STEM) in an immersive setting using Space Exploration as the theme and backdrop. This same technique is applied in our educator programs and not only teaches our educators but provides learning tools and inspiration that they can take back to the classroom. In FY13 228 teachers received scholarships to attend Space Academy for Educators, and 527 students were scholarship recipients. Based on restrictions from donors, travel, expenses are often covered by the scholarship funds in addition to lodging and meals throughout the program. More information about the programs of the U. The Foundation granted funds to the U. S. Space & Rocket Center to fund additional museum exhibitions. During the fiscal year the museum hosted two traveling exhibits. The first was an Evergreen exhibit titled MathAlive. The second, an ASTC exhibit titled Black Holes: Space Warps and Time Twists. The museum also completed a permanent exhibit titled Carrying out the Mission. This exhibit is located in the Saturn V Hall where the story of the Saturn/Apollo program is told in great detail using a variety of exhibits and mediums. Carrying out the Mission focuses on the life of astronauts and the training involved in preparing for lunar missions. The exhibit has two authentic training simulators that were actually used by the astronauts. Another addition to the visitor experience was the arrival of the T-38 Talon. The supersonic jet plane was used by astronauts to train for shuttle missions. Funds were granted for the structural work for the aircraft and also for design and structural work for the A-12 Blackbird that will be displayed ornamentally.

4c (Code:) (Expenses \$ including grants of \$ 230,196.00) (Revenue \$)

The Foundation solicited funds from corporate and private donors to sponsor several major events throughout the year. The following events were supported by these funds: July 4th Fireworks, Apollo 17 Anniversary Celebration, Be-Ready Camp, the annual Explorers Ball, the NASA Great Moon Buggy Races, the Pass the Torch series of speakers which is open and free to the public, and finally the annual Space Exploration Celebration. All of the aforementioned events were hosted by the U.S. Space & Rocket Center but underwritten by funds raised by the Foundation. These events support the missions of the Foundation and keep the community at large engaged and up to date on what is current in the museum.
