The Mississippi Nurses' Foundation raises, accepts and disperses charitable donations to promote professional nursing and better health in Mississippi

The Foundation had an exciting year with the scholarship program continuing to increase with nursing students and nurses seeking degrees across the educational continuum (AD, BSN, MSN, PhD, DNP) with a total award of \$94,000. The Foundation is also in its third year funding of the Department of Health-Office of Tobacco Control grant for nursing students. This provided stipends for twenty nurses to attend MNA annual Convention and it teaches nurses and nursing students about the dangers of tobacco usage and provides resources for nurses and patients. The Foundation created new partnerships with a top automotive retailer and business owners to advance the foundation. The Foundation also held the first annual art show to raise money for nursing and introduce the Foundation to non-healthcare entities. In a continuous effort to promote infection control and school nursing, the Foundation has implemented its High Five Hand Washing program in 25 elementary schools in Mississippi touching the lives of over \$8,000 students annually. To ensure the Foundation is solid, an endowment was created with the Community Foundation of Jackson to ensure a stronger future for nursing. With over 50 volunteers, the Foundation was able to co-host a black tie gala that honored nurses for the work they do in touching lives, approved continuing education packets to ensure nurses are trained and understand best practices for their profession, awarded scholarships by engaging educators to review scholarship packets, served as board members for governing body of the organization and helped the Foundation have a successful raffle campaign by selling tickets.
