OUTREACH AND OPERATIONS THE YOLO BASIN FOUNDATION PROVIDED OUTREACH TO YOLO BYPASS STAKEHOLDERS THROUGH FACILITATING THE YOLO BYPASS WORKING GROUP A FORUM FOR PEOPLE WITH INTERESTS IN LAND MANAGEMENT IN THE YOLO BYPASS. THE FOUNDATION ALSO PARTICIPATED IN SEVERAL PLANNING EFFORTS RELATED TO WETLANDS CONSERVATION INCLUDING THE YOLO BYPASS FISHERIES ENHANCEMENT PLANNING TEAM.
