Founded in 1975 Community Resource Group, Inc. (CRG), headquartered in Fayetteville, Arkansas, is a 501 (c) (3) private, nonprofit, multi-state community development organization that helps people build secure and sustainable futures. We work to meet the changing needs of individuals and communities by applying creative solutions to long-term problems.

Our primary areas of expertise are:

4 A. Water and Waste Disposal - CRG helps small, rural communities construct, operate and maintain public drinking water and wastewater treatment facilities. Through on-site technical assistance, training, educational workshops, publications, and financing, CRG supports efforts in low-wealth communities to provide an uninterrupted supply of affordable drinking water and waste disposal services within an ever-changing regulatory environment. As a regional member of the national Rural Community Assistance Partnership, Inc., (RCAP), CRG provides technical services to rural systems in Tennessee, Alabama, Mississippi, Arkansas, Louisiana, Oklahoma and Texas. CRG is leaving behind better water and waste disposal systems, along with an increased local capacity to solve problems and leverage future opportunities. For the fiscal year 2013, CRG provided onsite technical assistance to 530 small and rural communities and utilities. CRG staff secured more than \$29 million in constructions financing to improve water and wastewater facilities in 33 small communities for over 13,000 rural households. CRG conducted formal trainings for more than 560 persons from over 160 communities during the year.

4 B. Access To Credit - Pressing social needs drive our lending as we help communities and families secure the basics of American life; decent housing and safe drinking water. We work hard to develop loan products and structure financing that makes a difference. Since success takes more than just money, CRG couples its lending products with technical assistance and education to help borrowers succeed. CRG has been designated as a Community Development Financial Institution (CDFI) by the US Treasury Department. This past year CRG provided:

* 18 new loans totaling \$1,943,700 to repair, upgrade or expand water and/or waste disposal services to rural community water systems.

* 63 new loans totaling \$201,200 to support incremental construction of homes by low-income families living in Texas border colonias

4 C. Affordable Housing - At CRG, home ownership is an important strategy for helping low-income families provide shelter, security and an opportunity to build assets. CRG is building affordable, energy-efficient housing in Starr, & Zapata Counties on the Texas-Mexico border. The nationwide meltdown in the home mortgage market, coupled with the slow recovery from the recession, has made it increasingly difficult for low-income families to secure home mortgage financing. CRG has intentionally slowed housing production and is currently re-evaluating its border housing strategy. Included in our re-evaluation strategy is our participation in a region-wide system for delivery of affordable, green housing to low-income families across the Rio Grande Valley (Cameron, Hidalgo, Starr, and Willacy counties). This systematic approach to production of affordable homes is funded by the Ford Foundation as part of Improving Livelihoods for Rural Communities through a wealth creation model. Wealth creation in rural America is based on the premise that low-wealth rural communities can increase wealth through a balanced approach to development that benefits the economy, the environment, and social inclusion simultaneously. Through this initiative, CRG facilitates and encourages regional thinking as a framework for addressing Valley-wide issues.

4 D. CRG Nonprofit Tech Support offers technology services designed to increase the overall productivity and capacity of nonprofit organizations and currently services 35 Arkansas nonprofits. Our tech support division has developed a unique approach to helping nonprofits by providing customer-focused services that are tailored to each organization's individual technology needs. CRG Tech Support receives a discretionary grant support from the state of Arkansas' Office of Community Services to provide data management services for the Low Income Home Energy Assistance and Weatherization Programs. With funding from this program, CRG Tech Support was able to author software that is now being used in 15 Arkansas community action agencies to efficiently track and service 213,000 low-income households eligible to participate in those state programs.

CRG Public Policy works constructively within the political and social arenas to advocate for laws and resources that remove barriers for economically disadvantaged people and communities. CRG uses the experience gained from our hands-on work in communities to inform our public policy voice. We work to promote the best interest of the people and communities we serve.

At CRG, our programs and activities are focused on community-wide solutions to individual problems and needs. Our goal is not only to help rural communities solve problems but, in so doing, improve the quality of life for individuals and families, and to leave the community in a better position to make decisions that will meet the challenges of the future.
