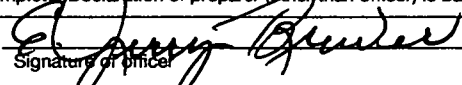

Scholarships are awarded to a select number of outstanding high school seniors who have participated in a franchised Dixie Boys Baseball, Inc. program and plan to pursue undergraduate studies at a college or university. Citizenship, scholarship and financial needs are the basis of the awards, with financial need being the primary consideration. While participation in the baseball program is required, athletic ability is not a factor in determining the scholarship award. A high class rating, evidence of strong community leadership and financial need are the minimum criteria for consideration of the award.
