Shelter and Transitional Living - Residential programs provide victims fleeing domestic violence with 24/7/365 crisis hotline assistance and immediate entry to safe shelter. Once in shelter, victims receive safety planning, case management, counseling, information about domestic violence and connections to community resources that help stabilize their lives and move them towards violence-free independence. Shelter clients are eligible for longer term transitional living and permanent supportive housing programs. The Organization operates two emergency shelters, one in Fort Worth and another in Arlington, where clients stay for the length of time required to complete their case management plan. Transitional living provides supportive services and rental assistance at scattered sites or at the Organization's own small apartment complex for up to two years. For qualifying clients, permanent supportive housing is available for an extended period of time, usually no more than five years. 2,101 SERVED DURING FYE 2013

Clinical Intervention - Non-residential outreach services are provided at two resource centers in Fort Worth and Arlington. Masters-level therapists provide individual counseling and support groups for adults and children. The Organization also facilitates the rehabilitation of batterers through an evidence-based, psycho-educational curriculum. The state accredited batterer's intervention and prevention program is the only service for which the Organization charges participants a fee. 1,891 SERVED DURING FYE 2013

Children's and Youth Programs - Specialized programming for children at the emergency shelters includes educational, recreational and therapeutic activities. Trained staff and volunteers provide therapeutic, educational childcare so mothers can attend work, seek employment or fulfill appointments. Children's advocates provide individualized case management and support groups. Licensed therapists offer play therapy and counseling. The Fort Worth shelter operates an onsite school using accredited teachers from Fort Worth ISD while the Arlington shelter enrolls children in Arlington ISD schools. The Organization operates a weekend camping program twice annually for child victims and a day camp program during the summer. 2,101 clients served during FYE 2013

The Store also honors vouchers for clothing for clients of other human service agencies in Tarrant County. Last year, more than \$26,000 in merchandise was given at no charge to victims of domestic violence as well as low-income and homeless individuals or families.
