Cook Children's Physician Network (CCPN) is the largest pediatric multi-specialty physician group in North Texas. The network includes more than 320 physicians and 160 mid-level providers in addition to thousands of other caring employees. During 2013, CCPN's provider count grew by 36 providers including 24 physicians (four primary care, three hospitalists and 17 specialists) and 12 midlevel providers (three pediatric nurse practitioners, six physician assistants and three certified registered nurse anesthetists). CCPN provides medical care in 60 locations at more than 30 primary care and subspecialty practices. Additionally, we offer access to nine specialties via telemedicine: Endocrinology, Gastroenterology, Genetics, Hematology and Oncology, Infectious Disease, Nephrology, Neurology, Neuropsychology, and Psychiatry. These specialists hosted 1,351 visits via telemedicine in 2013 (an increase of 49 percent over 2012) offering immediate care and patient education. This helped save many hours of travel for patient families. The network's physicians and specialists have offices in Tarrant, Denton and Hood counties and provide a primary care home in economically disadvantaged neighborhoods and areas where access to pediatric health care is difficult to come by. The physician network has also increased access to pediatric specialty care through outreach clinics in many communities in North, West and Central Texas. Each month, physicians travel to provide services in several areas that are not large enough to support full-time specialty care. Patients continue to benefit from the CCPN on-line patient portal, called mycookchildrens. To date, more than 65,000 patients, or their families, have registered for the portal (representing an increase of 33 percent from 2012), which provides families on-demand access to prior visit summaries, medication lists, vaccine records, lab results and appointment requests.
