Grand Teton National Park Foundation provides funding for the benefit of Grand Teton National Park for Inspiring Journeys A Campaign for Jenny Lake This restoration campaign will significantly upgrade the south Jenny Lake visitor complex and trails/bridges to Hidden Falls and Inspiration Point, improving hiking surfaces and viewing platforms, introducing interpretive material, and upgrading signage to clarify wayfinding The project will ultimately create a sustainable outdoor visitor center and trail system that will maintain the historic character of the area, yet improve safety, engage visitors, and aid the park in maintaining this popular destination each year

Grand Teton National Park Foundation provides funding for the benefit of Grand Teton National Park for the Youth Engagement Initiative-four programs that connected young people to the outdoors through a variety of experiences Youth Conservation Program, a teen crew comprised of 16-19-year olds who worked on park trails and historic sites while learning about stewardship, various park divisions, and outdoor recreation, Pura Vida and Young Stewards & Leaders, programs that engaged local Latino students and brought them into the park for education, recreation, and interpretation, and NPS Academy, a mentored internship program for diverse college students This initiative systematically introduces Grand Teton to a younger, more diverse audience and offers escalating educational and employment opportunities that keep participants actively involved in wilderness until they make career decisions

Grand Teton National Park Foundation provides funding for the benefit of Grand Teton National Park for the Wildlife and Natural Resource Initiative Funding supported research and protection of a wide variety of park species as well as projects that address threats to habitat Equipment, such as GPS tracking collars, was provided by Foundation donors and aided biologists in gathering vital data that was shared across the country and used to inform park, ecosystem, state, and national decisions Private funding also facilitated the development and implementation of public education programs that focused on wildlife conservation awareness and the implementation of an air quality monitoring station within the park In addition, Foundation funding brought bear-resistant food storage boxes to campsites in the park These lockers give park visitors a place to safely store food and other items that attract curious, foraging bears These metal boxes are critical items as they protect park bears from human food and protect park visitors from bears that become aggressive once they associate people with food
