awarded Disability Rights Washington (DRW) a three-year grant. The purpose of the grant is to improve the statewide sexual assault

response system. The project is focusing on adults with disabilities who receive long-term care supports and services. People with

disabilities who require long-term care have increased risk of sexual abuse. They may live in disempowering or isolated

environments. Often, people with disabilities who are victims of sexual abuse are not believed, they receive no victim services, and

perpetrators are not held accountable.

DRW is partnering with the Washington Coalition of Sexual Assault Programs and the Washington State Long-Term Care

Ombudsman. This team is working together to determine the needs of survivors, develop the project to make systemic change within

respective statewide organizations, and improve the response to sexual violence in the lives of people with disabilities in long-term

care. The three partner organizations are conducting the project needs assessment, implementing grant activities and advising the

project collaboratively.

National Disability Rights Network (NDRN) \$ 19,372

DRW has a subcontract with the National Disability Rights Network which has a contract with the Social Security Administration (SSA)

for the purpose of conducting preliminary reviews of entities acting as representative payees for people with disabilities who are

receiving SSA benefits. The purpose being to hold fiduciaries accountable when they misuse the funds of people with disabilities.

In 2013 DRW completed 8 investigations with findings of fact in Washington state.

Form 990 Part VI Line 11 - DRW prepares a draft of the form 990 and then it is given to the Executive Director for review. After making any revisions and before it is mailed to the IRS, a pdf copy of the form 990 is emailed to the members of the Board's Finance, Audit and Development Committee. They notify DRW's Controller if they think a change is needed. Then after that a revised copy is sent to DRW CPA firm tax department for final review.

Form 990 Part VI line 12c DRW has a conflict of interest policy for both its Board and its staff members. Once a year the topic is discussed and individuals are required to sign a code of Ethics Certification form.

Form 990 Part VI Line 15 - Once a year the Board of Directors Executive Committee meets to prepare the Executive Directors performance appraisal and pay review. Periodically in preparing the pay review comparative information is collected from form 990s of similar organizations across the country as well as other non profits in the state of Washington. Also considered is the prior salary history.
