GROW accepts and is responsible for grant monies and other donations received on behalf of a community garden or neighborhood project. GROW is responsible for ensuring the accurate accounting of all gifts, grants, payables, obligations and disbursements and that reporting requirements are met.**4b** (Code:) (Expenses \$ 17,558 including grants of \$ 0) (Revenue \$ 17,558)Seattle P-Patch Market Gardens' mission is to help establish safe, healthy communities and economic opportunity through development of CSA and Farm Stand enterprises in low-income neighborhoods. Seattle P-Patch Market Gardens is a partnership between in-city gardeners and consumers resulting in weekly deliveries of high-quality, farm-fresh, organic produce during the growing season and a weekly on site farm stand. In 2013 Seattle P-Patch Market Gardens provided produce for approximately 57 households over 20 weeks. It currently has two community supported agriculture (CSA) gardens located in and worked by residents in Southeast and Southwest Seattle. Each garden also sells produce on site at a weekly farm stand. The program is EBT (Food Stamp) eligible. Seattle P-Patch Market Gardens works with the West Seattle Food Bank Program to address local food security issues. The P-Patch Community Gardening Program also works closely with respective community councils and neighborhood groups to set priorities for garden management and development. The Department of Neighborhoods provides staff to work with low-income communities to develop and manage the gardens.**4c** (Code:) (Expenses \$ 42,458 including grants of \$ 0) (Revenue \$ 42,458)The P-Patch Community Gardening Program, a program of the City of Seattle Department of Neighborhoods, oversees 88 P-Patches distributed throughout the city. Community gardeners grow food on 14.9 acres of the land and in addition steward 18.8 acres for the public for a total of 32 acres. P-Patch Community Gardens spring from the desire of neighborhoods to make connections and improve their surroundings through stewardship. All P-Patch Community Gardens are open to the public to enjoy and are used as restorative spaces, learning/idea incubators and places to gather and visit. The gardens also provide a way to give back to the community: gardeners contributed over 32,690 hours in 2012 (equivalent to 15.7 full time workers) and show their concern for the value of organic vegetables and community by supplying fresh produce to Seattle food banks and feeding programs. In 2014 alone, P-Patch gardeners donated over 29,000 pounds of fresh produce to Seattle food banks and feeding programs. GROW provides liability insurance and garden tools to p-patch community gardens. GROW also pays for garden plot usage fees for low income gardeners who may otherwise be unable to benefit from gardening opportunities.
