The ArtCouncil, Inc. d/b/a Artadia The Fund for Art and Dialogue is a 501(c)(3) not-for-profit organization that gives visual artists unrestricted financial awards and a national network of support. Artadia currently operates in six cities: Atlanta, Boston, Chicago, Houston, Los Angeles and San Francisco and has its base in New York. We rotate and run award cycles in these six cities where we have an open application and ask prominent curators to act as jurors. Artadia offers all Awardees a chance to participate in our programs, including an artist-in-residence program at ISCP in Brooklyn, NY, our publications, interactive website and exhibitions and talks around the country. In FY2013 we continued to operate out of DUMBO New York where we have a small exhibition space in conjunction with our office. Artadia ran award cycles in Chicago and Houston in FY12 and awards were dispersed in FY2013. In FY2013, we ran two award cycles, one in San Francisco and our inaugural award cycle in Los Angeles and had a partnership with NADA and EXPO Chicago to run awards at the fairs.
