Youth Art Program - Nature Consortium's Youth Art Program (YAP) enables some of King County's most underserved youth to access quality out-of-school programs that augment their education, while also exposing them to artistic, environmental, and cultural experiences that enrich their lives at absolutely no cost to them. The program aims to increase participants' artistic skill, advance participants' environmental learning and awareness, foster positive identity, and increase social competence. Our two anchor locations are based in subsidized public housing communities in Rainier Vista and Yesler Terrace, but we also offer classes on a fee-for-service basis at community centers and libraries around King County.

**4b** (Code ) (Expenses \$ 160,106 including grants of \$ ) (Revenue \$ 6,949 )

Urban Forest Restoration Project - this is a long-term, on-going habitat restoration, stewardship, and education project in the West Duwamish Greenbelt (WDG), which is the largest remaining contiguous forest in Seattle. The WDG is an important ecological resource for the entire King County region and is home to a wide range of bird species and wildlife and provides recreational opportunities for the region's residents. In fiscal year 2013, 2,889 volunteers were engaged in 148 volunteer work parties and 8,932 hours of service, and 1,428 hours of education. During this time, 920 native trees and 3,209 native shrubs and understory were planted, tons of invasive vegetation was removed from 751,480 square feet of forest, and over 60 acres were maintained and stewarded.

Arts in Nature Festival - this community festival encompasses music, dance, theatre, aerial and fire performances, interactive arts activities, outdoor art installations, and a museum of sound comprised of multi-media sound installations in 8 rustic cabins throughout the park. The festival is hosted at Camp Long in West Seattle. During fiscal year 2013, the event engaged over 3,000 festival attendees, 30 volunteers and 145 local musicians and artists in 43 performances, 9 sound installations and 4 interactive arts areas.
