RESTATED ARTICLES OF INCORPORATION

ROGUE VALLEY MANOR MEMORIAL FOUNDATION, SECRETARY OF STATE

The Articles of Incorporation of Rogue Valley Manor Foundation, Inc., an Oregon nonprofit corporation, are hereby restated pursuant to ORS 65.451 as follows:

ARTICLE I.

The name of this corporation shall be Rogue Valley Manor Foundation, Inc., (the "Foundation") and its duration shall be perpetual.

ARTICLE II.

This corporation is a public benefit corporation.

ARTICLE III.

This corporation will have one member which will be the sole voting member, namely, Pacific Retirement Services, Inc., a corporation organized for charitable purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code of the United States of America. The purposes for which the corporation is organized are.

- (a) To educate the public in all aspects of congregate care and to promote the public welfare.
- (b) Promote and support by donation, loan or otherwise, the interest of the Rogue Valley Manor and other organizations described in §§ 501 (c) (3) and 509 (a) of the Internal Revenue Code of 1986, as amended (the "Internal Revenue Code").
- (c) Raise funds for any or all of the organizations described in subsection (b) of this section from the public and from all other sources available; and receive, maintain and administer such funds and expend principal and income therefrom in furtherance of these purposes.

ARTICLE IV.

The Foundation is organized, and shall at all times be operated, exclusively for charitable, educational, and scientific purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, by making distributions which exclusively benefit or carry out the charitable, educational, and scientific purposes of Rogue Valley Manor, an Oregon nonprofit corporation (the "Corporation"), Pacific Retirement Services, Inc. and its affiliates as described in paragraph (b) of Article III, so long as the Corporation is organized, and at all times operated, as an organization described in section 509 (a) (1) or (2) of the Internal Revenue Code.

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its directors, officers, or other persons or organizations whose net earnings, or any part thereof inures to the benefit of any private shareholder except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office except as authorized under the Internal Revenue Code of 1986. Notwithstanding any other provision of these articles of incorporation, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code of 1986 as amended (or corresponding provision of any future United States Internal Revenue Law) or (b) by a corporation, contributions to which are deductible under Section 170 (c) (2) of the Internal Revenue Code of 1954 (or the corresponding provision of any future United States Internal Revenue Law).

It is intended that the Foundation shall have and continue to have the status of an organization which is exempt from federal income taxation under section 501 (c) (3) of the Internal Revenue Code, which is other than a private foundation as defined in section 509 (a) thereof and to which contributions, bequests, and gifts are deductible for federal income, estate, and gift tax purposes under sections 170 (c) (2), 2055 (a) (2) and 2522 (a) (2) thereof, respectively. These Articles of Incorporation shall be construed, and all powers and activities of the Foundation shall be limited, accordingly. Notwithstanding any provision of these Articles of Incorporation, the Foundation shall not carry on any activities not permitted to be carried on by a corporation having such status.

ARTICLE V.

The number of directors and their terms of office shall be provided in the by-laws of the Foundation.

ARTICLE VI.


In the event of dissolution of the corporation, the board of directors shall, after paying or making provision for the payment of all of the liabilities and obligations of the corporation, distribute all of the assets of the corporation to Rogue Valley Manor or to its designee, provided, Rogue Valley Manor or such organization, or organizations are organized and operated exclusively for charitable, educational, religious, or scientific purposes as shall at the time qualify as an exempt organization or organizations under Section 501 (c) (3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law), and exempt from taxes under Oregon excise tax laws, as the board of directors shall determine. Any such assets not so disposed of shall be disposed of by the Circuit Court of the State of Oregon for Jackson County or other court of competent jurisdiction exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes.

ARTICLE VII.


No director or uncompensated officer shall be liable to the corporation for monetary damages for conduct as such director or uncompensated officer for any act or omission occurring on or after the date of filing of these articles, however, such limitation of liability shall not be applicable to:

- A. Any breach of the director's or officer's duty of loyalty to the corporation, or fraudulent or dishonest conduct, or gross abuse of authority or discretion, or
- B. Acts or omissions not in good faith or which involve intentional misconduct or a knowing violation of law, or
- C. Any unlawful distribution, or
- D. Any transaction from which the director or officer derived an improper personal benefit, or
- E. Any act or omission in violation of ORS 65.361 to ORS 65.367.




