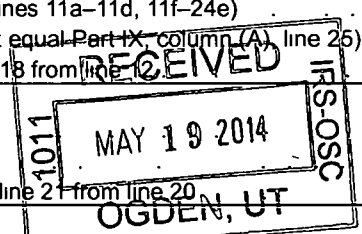

##### 4a) (Expenses **\$254,704** including grants of \$254,704) (Revenue \$254,704)

These expenses were associated with a project funded by a Math and Science Partnership grant from the Oregon Department of Education to further expand the Mathematics Studio model in Oregon as context for *establishing a proven, school-based mechanism* for institutionalizing a culture of mathematics professional learning that is guided by a clear research-based vision of how students learn mathematics. This project, which ended on September 30, 2013, charged Teachers Development Group (TDG) with creating flagship Oregon sites (in Bend – La Pine Schools and Medford School District) that supported teaching excellence locally and that will continue to support dissemination of the Math Studio model to other Oregon and national districts. During fiscal year 2012-13, work on this project included mathematics professional development in Bend and Medford involving over 200 teachers and school administrators in 30-120 hours of professional development. Many of these educators participated over multiple years of the project, directly impacting between 9,000- 11,000 K-12 students.

##### 4b) (Expenses **\$349,380** including grants of \$349,380) (Revenue \$349,380)

These expenses were associated with six-year project, *Mathematics Studio Fellowship Program – A Model for Mentoring New and Master Teachers*, funded by the National Science Foundation (NSF) through NSF grant #0934953. This project focuses on the development of Master Teaching Fellows, classroom teachers who receive school-based coaching by TDG consultants (K-12 master teachers) in high needs schools that have served as pilot sites for TDG's *Mathematics Studio* model. Since the inception of this project, work has involved Fellows in Oregon, Washington, Georgia, and Tennessee, where many participating high-needs schools have shown dramatic and continuous gains in mathematics achievement, and the program has expanded to include a broad base of teachers, teacher leaders, and school and district administrators.

4c) (Expenses **\$307,542** including grants of \$307,542) (Revenue \$307,542). In August 2012, TDG received a \$2.5 million, 4-year award from the National Science Foundation DRK-12 program to study the efficacy of the *Mathematics Studio* professional development model. TDG's Linda Foreman serves as Principal Investigator of this project, *Enhancing Mathematics Teaching and Learning in Urban Elementary Schools* (EMTL). Portland State University's (PSU) Department of Mathematics and Statistics is a sub-awardee, and all of the work is situated in Tacoma Public Schools in Tacoma, WA. EMTL project funding supports three years of professional development for all grades 3-5 teachers and principals in Tacoma Public Schools, and the funds support 4 years of research centered on that professional development. All professional development is provided by TDG staff members, and all research for the project is conducted by mathematics educators and researchers from TDG and PSU. All expenses named above are associated with the professional development and research for this project.
