The Asante Foundation's primary exempt purpose is to raise monies and in-kind donations to further the exempt purpose of Asante, a 501(c)(3) hospital and healthcare system which services the healthcare needs of the citizens of southern Oregon and northern California.

Form 990, Part III, Line 4a - Program Service Accomplishments

During the tax year, the Asante Foundation's largest program service accomplishment was the granting of \$867,740 to benefit various departments and capital projects at Rogue Regional Medical Center (RRMC), a 378 licensed bed hospital located in Medford, Oregon.

Of the capital projects, over \$359,000 was donated to remodel the Frances Cheney Family Place. Much like Ronald McDonald House, the Frances Cheney Family Place is a home away from home for family of patients at RRMC. This generous donation allowed the rooms, kitchen area, and gardens to go through a much needed renovation.

Over \$93,000 was donated this year to complete the Neonatal Intensive Care Unit (NICU) remodel and expansion. This capital project almost doubles the overall size of the NICU and adds an additional 10 bassinets and giraffe beds. All new high efficiency lighting and patient monitoring systems are included in the project. Now completed, the overall increase in patient volume is expected to be modest, but the major focus of the new expansion is to increase the efficiency and quality of care to the babies and their families.

Another major capital project includes the completion of the fundraising campaign to purchase a new \$5 million state-of-the-art radiation tomotherapy machine. Nearly \$41,000 was raised this year to complete the project.

In addition to donations for capital projects, the Asante Foundation also helps support numerous clinical departments at RRMC. This includes generous donations of

over \$120,000 to the Hospice department, \$22,360 to the Social Services department, and \$107,800 to help operate the Francis Cheney Family Place. The Inpatient Rehab Department received \$20,900 of donations. The Foundation also provided nearly \$27,000 for free mammograms and breast cancer education for uninsured women in the valley. Other donations help support the Women's Imaging Center, the Emergency Department, the Mental Health department, and the Dubs Cancer Center.

Form 990, Part III, Line 4b - Program Service Accomplishments

The Asante Foundation's second largest program service accomplishment is the granting of \$195,302 to help support various departments and capital projects at Three Rivers Medical Center (TRMC), a 125 licensed bed hospital located in Grants Pass, Oregon.

During the tax year, the Foundation contributed \$85,000 toward the purchase of a HUGGS security system. This system provides security for the Obstetrics and Pediatrics departments. The Foundation also made contributions of over \$4,000 to purchase medical recliners for the Medical Nursing floors and \$8,900 toward the construction of the new Three Rivers Outpatient Clinic.

In addition to capital projects, the Foundation contributed over \$95,000 in general operating donations. This includes \$38,200 to the Three Rivers Family House, and \$17,600 to the Spears Cancer Center. Over \$37,400 was donated to help subsidized free mammograms to uninsured women through a generous grant from the Connie Fiske Foundation. Other departments that benefited from Foundation donations include the Emergency Department, the Imaging Department, and the Diabetes Care Center.

The Foundation, partnering with the Regence Foundation and Asante Physician Partners, committed over \$117,362 to cover the costs of conferences and education for nurses and other medical personnel to learn more about palliative care and pain management.

The Asante Foundation's on-going mission is to continually assess the needs of the hospitals and physician groups it supports, as well as the community we serve. Over the years, the Foundation has contributed millions of dollars to help subsidize important clinical departments of the hospitals and help purchase needed medical equipment. It has also made significant contributions to major building projects at Rogue Regional Medical Center and Three Rivers Medical Center.

The Asante Foundation is considered a 509(a)(3) Type I supporting organization. The Asante Foundation has no stockholders, however has one sole "member". That member is Asante, a 501(c)(3) hospital and healthcare system. Though the Asante Foundation operates with a great deal of autonomy, Asante does have the right to elect the members of the governing board, has the right to approve significant decisions, and can require the Foundation to distribute a share of its profits and can require a share of the Foundation's net assets upon the its dissolution.

the review, Accounting will clear all review notes. The Asante Foundation's Board of Directors will look over the final set of returns and make further comments or corrections, as is appropriate. Once all reviews and corrections are made, the CAFO will sign all appropriate returns for filing. The return will then be filed either electronically or paper copy with the appropriate government agencies. A copy of the return is to be kept in Asante's Accounting department and another will be kept at Asante's corporate headquarters for public display and copying, as requested.
