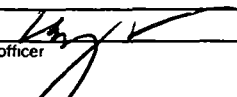
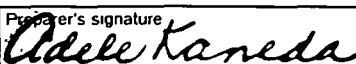

Through collaboration across sectors, we develop population-level approaches to create systematic, comprehensive strategies that alter community conditions.
