THE USS ARIZONA MEMORIAL AUDIO TOUR PROVIDES IN-DEPTH INFORMATION ON MORE THAN 20 LOCATIONS WITHIN THE PARK, INCLUDING THE WAYSIDE EXHIBITS, ON-SITE MUSEUMS, AND THE USS ARIZONA MEMORIAL. THE TOUR INCLUDES COMMENTARY FROM PEARL HARBOR SURVIVORS AS WELL AS NATIONAL PARK SERVICE HISTORIANS.
