The Humanities to Go speakers bureau makes 200 high-quality humanities programs available to non-profit and community organizations across the state. These programs are open to the public free of charge. Humanities To Go brings neighbors together for learning and thoughtful conversation and connects NH residents to our state's rich historical and cultural resources. This deceptively-simple program offers a lifeline to cash-strapped local organizations that could not afford to create or pay for such programs on their own. In 2013, Humanities to Go again broke records in the number of programs offered: 491, organizations booking talks: 276 and people reached: 19,640. Additionally, Humanities to Go served 156 communities during the year.

In 2012, the NHHHC launched Constitutionally Speaking with its partners, the UNH School of Law and the NH Supreme Court Society. The pilot project was designed to educate the adult public, K-12 teachers and students about the U.S. Constitution and to engage young and old in civil, spirited dialogue about its interpretation over time and its importance in our lives today. There were 14 Constitutionally Speaking events during the year and an audience of approximately 1,200 attended the events. The Council also conducted Making Sense of the Civil War, which is a five-part book discussion/lecture series hosted by NH libraries to rave reviews and participant waiting lists. The readings include historical fiction and interpretation, speeches, diaries, memoirs, biographies and short stories. In the Spring and Fall of 2012, our facilitator/scholars led series in several New Hampshire towns and cities. There were 10 Civil War book discussions during the year and an audience of 185 individuals attended.

Community Project Grants enable the NHHHC to be responsive to the needs and interests of New Hampshire residents. In 2013, the NHHHC Board of Directors, through its Program Committee, awarded 21 competitive grants, which were matched by 135,197 in cash and in-kind community support. Local innovative humanities programming made possible through grant making included regional community book, film, lecture and discussion series, teacher professional development workshops, author visits and community oral history collection and presentation.
