

Part VI, 11b - The Treasurer prepares the form 990 return and files a copy with the corporate records. The corporate records are open and available for review and inspection to all officers, directors and key employees of the corporation.

Part VI, 19 - The corporation did not receive any requests for review of the documents identified in line 19. There are corporate documents which are publicly available through the State of Maine's Bureau of Corporations website.
