Summary of Direct Charitable Activities

The rainforest land was purchased to achieve the Foundation's mission to preserve the land as a natural habitat for wildlife as well as an area for environmental study. The land, adjacent to the Corcovado National Park of Costa Rica, is a part of the biological corridor for the wildlife of the Carate-Corcovado region. Environmental and educational groups and other visitors are able to stay, study and become engaged in the ongoing efforts to preserve this biologically intense area of the Osa Peninsula. In addition to improvements and renovation of the existing buildings, construction is underway for new student quarters in order to expand the service to university groups as a functional research station. Osa Conservation volunteers continue to use the facility while participating in the local project to save turtle eggs from poachers and return them safely to the ocean. The foundation participates with other non-profit organizations and the local community in research and responsible eco-tourist development for living sustainably with the environment.
