Every year, the 6th District holds its week-long boys camp for boys age 8-14 at Camp Hanes YMCA in King, NC. We hosted 139 boys, along with 40 counselors. Each chapter is required to send at least one (1) boy from its respective geographical area. The camp is usually a culmination of a year-long mentoring program from each area. The camp focuses on many issues including mentoring, anger management, conflict resolution, and healthy lifestyles.

Talent Hunt Program provides exposure, encouragement and financial assistance to talented young people participating in the performing arts.
