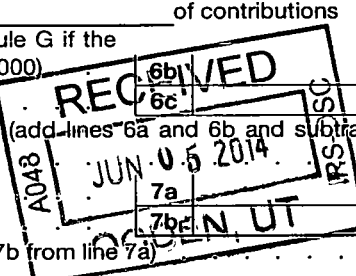

1. Rocky Mountain Neurosurgical Society Inc. is a corporation, organized in 1976, which provides an annual scientific meeting for neurosurgeons. During the current fiscal year ended November 30, 2013, the annual meeting was held in Sun Valley, Idaho, June 15, 2013 through June 19, 2013. There were 65 attendees.
2. For many years, the corporation filed a Form 990EZ claiming a tax-exempt status as a 501(c)3 organization. On February 28, 2014 the Internal Revenue Service notified the corporation that its tax-exempt status should be as a 501(c)6 organization. Accordingly, this tax return recognizes the 501(c)6 status.
3. The cash balance as of November 30, 2012 was erroneously overstated by \$14,847 on the previous tax return. The adjustment to correct this overstatement is reported on L 20 of the current return.
