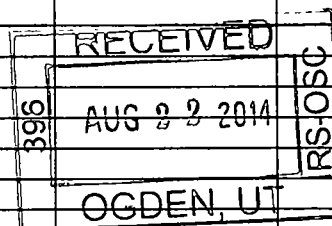

Statement Regarding Treatment of 2012 Grant to Carolands Foundation

During its 2012 tax year, the filing organization made \$1,900,000 in grants to Carolands Foundation (EIN: 46-1631709), a private operating foundation.
