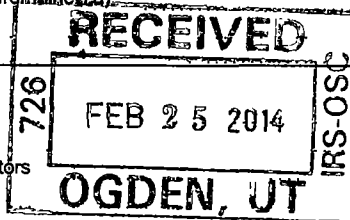



This year started with our annual dues billings which provided discounts for our members. Our reserves are fully funded so we are able to refund some of the dues we collect to lower the costs of membership as well as help subsidize mover attendance at our convention for those companies which have not participated in the past. The MMA and MPSC act independently but cooperatively to isolate moving service providers listed on Craigslist and other media which may not be licensed or participating in our tariff. We contact these companies and explain what steps must be taken for them to be in compliance. That led to over 20 new movers joining the MMA last year.

Our annual convention featured professional speaker Jim Mathis as our keynote and his message was well received by the attendees. We offered

free registration to movers who had never attended the convention in the past, and that let to over 20 new participants. We had twelve exhibitors and several meal and financial sponsors which added value to the event and helped offset some expenses. The 2013 event was held at the Greektown Casino & Hotel and the board enjoyed their hospitality to the point that we will be returning in 2014.

The MMA initiated an Academic Scholarship Fund this year (MMA-ASF) to provide \$500 scholarships to college or trade school students. We had four outstanding applicants, each of whom received a scholarship payable to their university. Each recipient was congratulated in our Fall issue of The Carrier, and invited to the 2014 MMA Convention. The scholarship program was highly successful, and the MMA board voted to increase funding for the 2014 academic year.

The MMA once again published four high quality quarterly newsletters, and communicated regularly with members through email and Constant Contact to provide information on MMA activities and other current events.

The MMA board voted to pursue an 8% increase in tariff rates this year. Coupled with that initiative were proposed technical changes to the tariff and Motor Carrier Act. Those actions are still pending as of the MMA fiscal year end.
