

**THE FOUNDATION**

The Chuan Lyu Foundation is a private philanthropy dedicated to the preservation of the culture and history of the Taiwanese people. The current Foundation emphases are:

- 1). Development of ideas and practical means that will promote increased participation by the public citizens on the decision-making process of the government.
- 2). Development of ideas and ways to propagate respect for individual's rights and to promote justice in the process of law enforcement.
- 3). Promotion of public education and policy studies that will contribute to the conservation of natural resources and environment.

**PROGRAM**

- 1). Chuan Lyu Fellow Program: Awards fellowship to exceptionally creative and dedicated individuals at a point in their careers when fellowship support could make a marked difference.
- 2). General Grant Program: Awards training and research fellowship grants, community grants and cultural grants.

**CHUAN LYU FOUNDATION**  
**ALLOCATION OF GRANT ADMINISTRATIVE EXPENSES**

Basis used to allocate administration expenses to charitable activities:

With respect to the allocation of expenses for purposes of the computation of net investment income, it has been the practice of the foundation to claim as deductions one-half of the accounting fees incurred in the preparation of the foundation's tax and information returns and related matters, fees charged by brokerage firms (other than commissions which are taken into account in the capital gains computations), filing fees paid by the foundation and other expenses incurred in preparing the foundation's returns and otherwise satisfying the various Federal and state filing requirements.

With respect to the allocation of expenses for charitable purposes, it has been the policy of the foundation to allocate all legal and related fees, administration fees incurred in advertising the existence of the foundation (eg: membership in exempt organization societies, etc.) and other non-investment related costs (i.e.: P.O. box rental) entirely for exempt purposes since such expenditures relate directly to the furtherance of the exempt purpose of the foundation.
