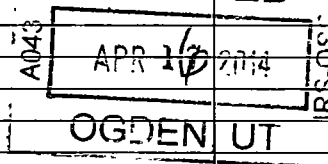

EXPLANATION FOR REDUCTION CLAIMED FOR BLOCKAGE OR OTHER FACTORS

THE FOUNDATION HAS A ROYALTY AGREEMENT FROM THE ESTATE OF MR. DAVID WILCOX. THE AGREEMENT IS WITH ALLEGRO FINE FOODS, INC. AND CALLS FOR THE PAYMENT OF A ROYALTY TO THE FOUNDATION FOR THE USE OF PRODUCT FORMULAS DEVELOPED BY MR. WILCOX DURING HIS LIFETIME. THE ROYALTY IS BASED ON SALES OF PRODUCTS BASED ON THESE FORMULAS. THE AGREEMENT CALLS FOR A MINIMUM ANNUAL PAYMENT OF \$25,000 AND A MAXIMUM ANNUAL PAYMENT OF \$100,000. THE INITIAL VALUATION OF THE ROYALTY AGREEMENT WAS BASED ON THE MAXIMUM ANNUAL PAYMENT OF \$100,000 USING A LONG TERM INTEREST RATE OF 3.55%. THE FAIR MARKET VALUE IS REVISED FOR ACTUAL ROYALTIES RECEIVED DURING THE CURRENT YEAR AND A LONG TERM INTEREST RATE OF 5.00%.
