KELT manages a land protection program that works with dedicated volunteers, landowners, municipalities, other environmental organizations and state agencies to achieve successful outcomes.

The Stewardship program is dedicated to the perpetual care of the preserves and conservation easements held by the Kennebec Estuary Land Trust.
