In 2013, the organization celebrated it's 10th anniversary of full operations. The organization produced and presented 97 concerts and events for the community, offering a continuous schedule of performing arts events suitable for adults and children of all ages. Producing concerts and providing programs and events open to the general public help the organization accomplish its mission of operating a community arts center that enlivens and enriches the lives of local citizenry.

In 2013, the organization continued to make its facility available for use, either gratis or for a nominal fee, for a myriad of public, civic and non-profit organizations for events attended by the general public.

In 2013, the organization continued its collaborative after school arts program with the Boothbay Harbor Memorial Library. In addition, the organization hosted community events related to holidays, such as Halloween, Christmas, and Valentine's Day.

Hosting family oriented events for the community, sponsored by both the organization and other local non-profit organizations, furthers the organization's purpose of operating a community arts center.

In 2008, the building was certified as a historic structure by the U.S. Department of the Interior and added to the National Historic Register. The organization continuously works to honor that designation.
