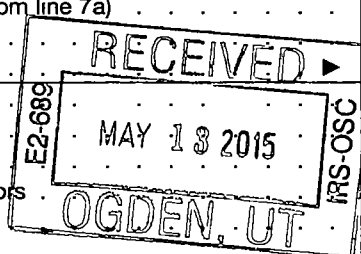

Streicher, advocate for homeless, dies in wreck

Members of Nevada County's homeless community and its supporters are mourning the loss of advocate Thomas Streicher, who died in a weekend wreck in Wyoming on his way back to feed Nevada City's needy after a trip to South Dakota's Pine

Ridge Indian Reservation, where he visited quarterly to provide food and other donated items.

"It's very shocking," said Cheryl Zellers, a former board member of Divine Spark, Streicher's charitable nonprofit. "I'm still in the mode where I don't believe it."

Returning from his 42nd charitable trip to the reservation,

Streicher, 58, died Friday evening after losing control of his vehicle along an icy stretch of Interstate 80, 45 miles east of Rock Springs, Wyo., according to Sgt. Stephen Townsend of the Wyoming Highway Patrol. Responding paramedics pronounced Streicher dead en route
